#### USE BODY LANGUAGE TO BUILD CONFIDENCE

he most powerful people in a group are not always the smartest or most knowledgeable. So, why are they the leaders? Often times, it is because of subtle body language that draws people to them. Here are six secrets that you can use today to exude confidence and feel powerful:

#### 1) Eye Contact Conveys Confidence

You know the feeling. When a person makes eye contact with you, especially when you are talking, you feel important to that person, and your confidence in that person grows. People who meet your seem sincere gaze trustworthy, while those who don't seem either dishonest or lacking in confidence. However, too much eye contact can be uncomfortable. It can feel like an intrusion or an act of aggression. Powerful leaders instinctively know how long to look at you and how long to look away, and do it naturally. Studies suggest the proper amount of eye contact in the U.S. and many other countries should be between 50 and 60 percent of the conversation, mostly when listening.

#### 2) Smile: It's Good for You!

Many studies have been done on the benefits of smiling, but common sense also tells us that when we smile, we feel better inside, and others smile back. But why is that? It has to do with the chemicals that are released in the brain when we smile or see other people smile. Smiling triggers the "feel good" hormones like serotonin, and dopamine. endorphins. These powerful chemicals relax your body, reduce your heart rate and blood pressure, and help you fight off stress. This makes you feel healthier and appear more confident. What's more, your smile triggers other people's brains to respond in kind—in other words, a smile is contagious. Powerful leaders smile enough to convey confidence and good will, while creating bonds of respect.

#### 3) The Firm Handshake

The perfect handshake is brief, firm but not tight, and uses the whole hand, not just the fingertips. It conveys that the person is confident, extroverted, and positive. This can't be emphasized enough. handshake creates an immediate impression, and you only get one chance to create that first impression. Powerful leaders shake hands in a way that says, "I am strong and in control." Often, people that have a poor handshake have no idea. Try it out on a trusted friend or colleague and ask for honest feedback.

#### 4) Take a Powerful Pose

Strong leaders convey their self-confidence and strength subtly but clearly through their posture. An outstretched, open posture projects an image of power and confidence. Legs slightly apart, hands on hips (think wonder woman), or making wide gestures make you look like you are in charge. But

it not only makes others think that, it makes you think that, too! By practicing power poses before presentations or meetings, you boost your confidence and subconsciously tell the audience you're in control, confident about the future, and able to set goals and act.

#### 5) Voice Tone

We all know that animals can hear undertones outside of human range, but the fact is that we unconsciously hear them, too—and make decisions based on them. You know how a high, nasal, or thin voice can be irritating (think Fran Drescher), but a broad, resonant voice (think Don LaFontaine) is soothing and attractive. That's because of the undertones. Incredibly, studies have shown that hearing those low tones actually makes people more efficient, while removing the low tones makes people less efficient. Leaders have the best undertones, and people around them subconsciously match their tones to those of the leader. Have you ever heard the saying, "We're on the same wavelength"? Whoever made up that saying was right. That's exactly what happens.

#### **6) Appropriate Gestures**

Random or nervous gestures are distracting, but "speechassociated gestures" complement the words spoken and enhance their meaning. This does not mean a thumbsup or sign language. These symbols convey meaning without words. The best gestures, used by great speakers

and leaders, naturally support the words and make them easier to remember and understand. Leaders use gesture to get their point across effectively.

## **Are These Leadership Secrets Innate or Learned?**

Though many leaders do not study to develop these traits, anyone can learn to use them and harness them. If you'd like to exude more power and confidence, develop these subtle secrets of body language.

#### **SCHOLARSHIP AWARD RULES**

February 06, 2018

In the 2018 fiscal year, NALS of Greater Kalamazoo will present two scholarships, each for \$1,000. The scholarships will be awarded on the basis of scholastic or legal career achievement, future career goals, demonstration of financial need, and leadership ability. The scholarship award may be granted to any qualified applicant enrolled in a Michigan school of advanced education in the legal field.

#### The candidate must

- A. Be a high school senior; or
- B. Be enrolled in, or able to enroll in, a school of advanced education commencing with the ensuing school term.
- C. Be in need of financial assistance.

Non-winning candidates from prior years who meet current qualifications are eligible for renomination. Prior winning candidates who meet current qualifications are eligible for renomination two years (2) after winning the award.

The application and all required attachments must be submitted and postmarked no later than **Friday, April 13, 2018**. Any application postmarked after that date will be disqualified.

In the event a selected recipient does not accept the scholarship award, the scholarship will be awarded to the next highest candidate in order. The scholarship recipient must notify NALS of Greater Kalamazoo of his/her final decision regarding enrollment in a school of higher education no later than June 1, 2018. Should a selected recipient not enroll in the ensuing term of school, thereby forfeiting the award, it shall be presented to the first runner-up.

Periodic reports on the progress of the scholarship recipients shall be given to NALS of Greater Kalamazoo when possible. It is recommended that the Association maintain personal contact with the winner of the award and that they make a progress report from time to time. The Association would like to mentor and assist the scholarship recipients through their ensuing school year.

The scholarship monetary awards shall be paid directly to the school of the selected recipient's choice for enrollment in the ensuing term of school.

Any scholarship award is to be used in full within one year from the date of the written notification to the selected recipients of his or her selection. Any unused scholarship award, or portion thereof, shall be refunded by the school to NALS of Greater Kalamazoo by August 31, 2019.

This application must be <u>fully completed</u> with the exact required instruments attached to the application submitted to NALS of Greater Kalamazoo.


- 1. Attach an official transcript of grades.
- 2. Attach a one-page letter of recommendation addressed to NALS of Greater Kalamazoo from the student's current major teacher or counselor stating:
  - A. Applicant's activity and leadership record.
  - B. A description of applicant's personal traits, character, personality, drive and home background.
  - C. Reasons this applicant should be awarded this scholarship.
- 3. One additional letter of recommendation from someone other than a member of the applicant's family, such as an employer, teacher, pastor, or friend may be submitted if applicant so desires but is not required.
- 4. Attach a typed autobiographical statement no longer than three pages including information about schools attended, employment experience, school activities (honors, clubs, choir, band, sports, etc.), outside activities (church, civic, community service), accomplishments (awards, languages, etc.), family background, hobbies, and describing briefly applicant's career goals and desires. Also include information in this statement indicating how you intend to pay for your college education.


