The Board of Trustees met at the Hampshire Township Administration Offices at 170 Mill Ave., Hampshire, IL on the 8th day of September 2020 at 7:00 pm.

- 1) The meeting opened with a pledge to the flag. Mrs. Remakel asked for any changes or additions to the agenda. She would like to move Hampshire Township Development before Public Comment.
- 2) Minutes. The Board reviewed the Regular Meeting of the Board of Trustee Minutes on August 8, 2020. After reviewing the minutes, a motion was made by Trustee Gustafson to accept the minutes as presented. Trustee Bicknese seconded the motion and it was approved unanimously by all present.
- 3) Treasurer's Report. The Board reviewed the July Treasurer's report that was tabled from last month due to being off by \$.50. The error was found and corrected and new reports were given to the Board. A motion was made by Trustee Bicknese to approve the July Treasurer's report. Trustee Feld seconded the motion and it was approved unanimously by all those present. A roll call vote was taken.

<u>Highway Commissioner:</u> Mr. Walker reported that they have the new truck but still have a few things that need to be put on. They have been out hot patching. A new culvert was put in on Primrose Lane as well as one at a field entrance at Casa de Aero. They have also been out ditching. They will need to mow fence line to fence line again.

<u>Supervisor:</u> Mrs. Remakel reported that after listening to a webinar regarding the application process for the Cares Act, it looks like our amount will be closer to the \$15,000 mark. We are in the process of hiring new drivers for our Senior program as it is picking up again and we have lost some drivers to other obligations. The frozen meals on wheels program is continuing at this time.

5) Hampshire Township Development.

Discussion and Approval of Architectural Engineering Proposal. At this time, it is still on hold.

<u>Discussion of Land Accessibility.</u> Supervisor Remakel reported that she sent a letter to both of the neighbors. Linda Vietinghoff was in attendance as she had a few questions/concerns. Her family's main concern is they feel they will have issues with the other neighbor if the alley was vacated. They would like us to ask for ownership of the alley. We informed her our intent is to ask for ownership of the alley for the purpose of helping with variances for when we put on an addition. They do not have any more issues or concerns.

7) Old Business

<u>Cemetery Warranty Deed:</u> The attorney made an edit and Supervisor Remakel still needs to take a look at it. Still waiting to hear back regarding the property tax. The Board is ok with waiving it.

8) New Business.

<u>Discussion and Approval of Salary for next term.</u> Supervisor Remakel presented to the Board a memo from Trustee Paddock regarding his salary recommendations. Supervisor Remakel also presented to the Board two other salary recommendations. There was discussion on what the Trustees thoughts were regarding wages for new officials as well as what duties each official performs. The Board went through each positon with much discussion and then voted on what they would like for the salary.
