- Nominee must have distinguished themselves in good sportsmanship and integrity in league and tournament play.
- Nominator must submit a complete and legible application form detailing all accomplishments and achievements as indicated within the criteria and guidelines.
- Proof of membership or documentation may be required to meet qualifications and must be provided if requested. Failure to present requested documentation will result in disqualification.
- Incomplete or illegible nomination forms will not be accepted and will result in the nominee being disqualified.
- Submission of false information will result in the nominee being disqualified from nomination.
- A posthumous award may be awarded if the nominee is deceased.
- Completed applications must be postmarked by the deadline date of October 1[,] 2018. Applications postmarked after October 1, 2018 will not be accepted for processing.
