The 6-game Logo Infusion Challenge Qualifying Round is scheduled for Tuesday, November 15 at 10:00 AM on the 39' pattern. Logo Infusion and Storm have generously added \$3,000 to the Logo Infusion Challenge Prize Fund. 16 players from the Qualifying Round (including at least 2 Super Seniors) advance to the Logo Infusion Bracket Finals. Lanes WILL be re-oiled prior to the Bracket Finals which will begin approximately 90 minutes following the completion of the Qualifying round. Bracket Finals Round 1 is "Best of 5" single-game matches. Round 2 is "Best of 3". Rounds 3 and 4 are single-game matches. Roll call will be conducted 30 minutes prior to the start time of the Qualifying Round and 15 minutes prior to the Bracket Finals.

Lanes 1 & 2 and 59 & 60 are not scheduled for use during Qualifying and will only be used as contingency pairs during Qualifying. Lanes 1 & 2 will be used during the Logo Infusion Bracket Finals.
