AGREEMENT FOR SERVICES

1. This agreement for services is between the Graham County Fair and Racing Association (County) and _____ (Contractor).

2. This agreement shall become effective Thurs., October 11, 2018 and shall terminate Sun., October 14, 2018.

Services shall be provided on the following days and minimum hours of operation:

Thursday, October 11, 2018	6:00 p.m. – 12:00 a.m.
Friday, October 12, 2018	12 Noon – 12:00 a.m.
Saturday, October 13, 2018	1:00 p.m. – 12:00 a.m.
Sunday, October 14, 2018	12:00 p.m. – 5:00 p.m.

3. Services to be provided by contractor are: (describe in detail).

Provide a food concession to serve _____ and necessary manpower for the Graham County Fair. Location: Outside Food Court Space _____. It is permissible to have your booth open for business before or after the aforementioned hours.

4. The Contractor will perform these services as an independent contractor and not as an employee of the Graham County Fair/Racing Association or the County. Contractor will provide all necessary staff, equipment, supplies, electric power and other elements of cost necessary to perform the above service

5. The Contractor will pay to the County **Three hundred dollars (\$300.00)** in exchange for vendor space during the Graham County Fair.

6. This agreement may be terminated by either party by written notice thereof to the other party at least thirty (30) days prior to scheduled date(s) of services.

7. I/we understand that the above activity must be under competent supervision as jointly agreed upon between myself/us and the County’s representative. I further understand that I/we assume full responsibility for damage to the facilities/furnishings/grounds during the time assigned for our exclusive use, and I/we further agree not to change or alter the usage of the facilities/grounds without prior written approval of the County’s representative.

I/we further agree to hold the County, it’s representative(s) free and harmless from all loss, cost, damage, liability, which may be asserted against it by the undersigned or by any other person(s), by reason of/or arising out of the exclusive use of assigned facilities/grounds or by reason of any conduct or negligence of the undersigned or his/her representative or agent.

This agreement contains all terms and conditions. No other understandings, oral or otherwise, regarding the subject matter of this agreement shall be deemed to exist or binding on either party. Changes to the terms and conditions of this agreement shall be made only by written amendment hereto and signed by both parties.
