

What is Blaine's FARMacy CSA?

I have decided to change things up a bit, and offer a CSA to customers as an alternative to picking up their pre-determined weekly shares. With a traditional CSA share program, the customer comes to pick up their share (with what the farmer decides to put in) on a specific day of the week, at a specified time period. With this alternative idea, the customer would choose what they want, and when they want from my farm stand. CSA customers will receive the same amount of product, just a little different format, and added benefits. Here are the details:

- you will have a choice of a short term share of 10 weeks, or a long term share of 20 weeks
- you will be given a member "FARMacy" card
- your weekly cash allotment will be loaded on the card at the beginning of each week
- you will use this card when purchasing your weekly product (if you forget your card we will have it on file)
- you will receive a discount on all items in the store (25%)
- you will be able to shop at the stand any day of the week to fulfill your weekly membership amount (stand is open 9-7 daily)
- you can purchase any item, you are not limited to just the items I grow (for example, if you want a box of peaches one week, you can use your entire balance for peaches)
- if you purchase more than your weekly balance you will pay with another tender for the extra amount (cash, check, credit card) and still receive the member discount
- if you are out of town, or don't use all of your balance for the week, it will roll over to the next week
- there will be specialty items that I grow specifically for CSA members. They will be sectioned off and marked for members only!
- at the end of the CSA term, if you have a balance remaining, you will have 2 weeks to use it
- there is a \$10 administration fee
- CSA membership payment in full is required prior to term. Terms start May 2, 2016.
