Future of Amana Elementary

At the January 18 meeting of the Clear Creek Amana School Board questions were raised by Amana residents asking about the future of the elementary school in Middle Amana as some concerns and unconfirmed reports circulated about the school.

When contacted last week by the Amana Society Bulletin, Dr. Corey Seymour, CCA Superintendent, stated, "Thank you for the email. We will be sending out a detailed communication at the end of the month. Let me clear up a few rumors. There will be changes to Amana next year but closing the school is not one of them. As a matter of fact, we are planning to increase programming and improve facilities. I discussed some of the potential changes at the community meeting. The first thing I stated at the meeting was Amana would remain open. I understand that schools work as life lines for communities. My goal is to improve the community. Since the numbers at Amana are not growing or slowly declining, we have to be a little more creative to support the school."

Dr. Seymour held a community forum December 1 at the Amana Performing Arts Center, this is the meeting he refers to in the statement above.

The Amana Bulletin will be following up with Dr. Seymour when the detailed communication is received.

Amana Church's Restore Revive Renew Progresses News on Construction Timeline and Fund Drive

Receiving the National Trust for Historic Preservation – National Trust for Sacred Places grant in 2021 has propelled the Amana Church's efforts to restore the Main Amana Versammlungsaal (meeting house/ church) and the Middle Amana Kinderschule (preschool).

Calling the project "Restore Revive Renew" the Amana Church began a drive in 2021 to significantly improve both buildings for future use. It has made big headway in the last year.

Construction documents will be presented to the Amana Colonies Land Use District this spring, says Elly Hoehnle Amana Church administrator. The plan is to begin work on the buildings this summer.

Amana Church members will be looking at the plans at a special meeting at the Middle Amana Church on Sunday, Feb. 5 following 10 a.m. worship.

As of January 1, 2023 the Restore Revive Renew Fund Drive has raised \$333,641 in cash, pledges and grants. That's over 90 percent of its Phase 1 goal of \$364,387. This includes the initial \$70,000 grant from the National Trust for Sacred Places and a donation of \$50,000 from the Amana Society, Inc. As well, the Amana Community Food Pantry was awarded \$8,500 from the Iowa County Community Foundation for building rehab, report co-chairs Jon Childers and Emilie Hoppe.

"This project has really taken off and we've

seen such widespread, enthusiastic support for it from so many people," said Childers. "It's really been gratifying."

The Amana meeting house is the largest of the Amana churches and is used today for special services, weddings, funerals and public meetings and events. It is the home of the Amana Sunday School and it provides space for Bible studies and Monday "Senior" dining. Senior dining is on hiatus now but will return.

The Kinderschule is not being used at this time, but the Amana Church will put it to good use as the new home of the Amana Community Food Pantry. The Food Pantry provides food to an average of 30 families from the Amanas/lowa County every two weeks by accepting donations of food and cash.

The list of repairs/ rehab at the 1864 meeting house is long and includes:

- constructing a new handicapped accessibility ramp on the west side and replacing the east side ramp
- · repair all entrances
- replace upper story fire escapes
- remove 1950's era asbestos siding on the east and west sides. Replace with historically accurate clapboard siding
- repair or replace fascia and soffits
- repoint chimneys
- repair foundation retaining walls
- restore dormer windows
- repoint/ restore stone foundation.

At the Kinderschule, located behind the Middle Amana Church, it will take effort to make the building useable. Here's the list:

- make interior repairs to walls and floor
- add utilities, update electrical system, heating/ cooling
- add sidewalk
- · restore/ replace siding
- repair framing
- restore windows
- · repair porch and entryway
- repair foundation and repoint chimney.

The fund drive continues as the church works toward its Phase 1 goal and then begins the drive for the Phase 2 goal. The total estimated need is \$472,387 for Phase 1 and 2.

"We are getting close and we are so grateful to everyone who has contributed. I think the emotion behind each gift is telling – from what people have said or written with their donations – they feel like giving to this drive is giving back

Just a reminder that HP permit applications and their associated fees need to be in the ACLUD office by 5:00 PM on the Tuesday BEFORE an upcoming Historic Preservation Commission (HPC) meeting. And HPC has a standing meeting on the fourth Monday of every month. This is done primarily for two reasons; the meeting agenda must be finalized on that same Tuesday in order to be posted in the Amana Society Bulletin that week, and this also allows time for Amana residents to be aware in advance of changes and upcoming projects that have entered the permitting process. This same "5:00 PM Tuesday" deadline applies to new issues slated for the Board of Trustees meeting agenda (their standing meeting is the second Monday of each month) for the same reasons already stated.

Note: In the current political environment and with seemingly so little time to gather information, we listen to the news outlets that tell us what we already have a tendency to believe. What we hear may be biased, commentary or just plain sensationalism, "Whatever bleeds leads."

Gone are the days of Walter Cronkite and the news as a public service, now it's all about money. Watch the 1976 movie "Network" sometime.

Below are some the best fact checking websites available. (mediabiasfactcheck.com 2020 ratings)

- 1. Politifact— is a fact-checking website that rates the accuracy of claims by elected officials and others who speak up in American politics. PolitiFact is owned by the Poynter Institute, which also operates the International Fact Checking Network (IFCN) that sets standards for fact checkers. Politifact is a signatory of the IFCN and is simply the best source for political fact checking. Won the Pulitzer Prize.
- 2. FactCheck.org— is a project of the Annenberg Public Policy Center of the University of Pennsylvania. They are a nonpartisan, nonprofit "consumer advocate" for voters that aims to reduce the level of deception and confusion in U.S. politics. They monitor the factual accuracy of what is said by major U.S. political players in the form of TV ads, debates, speeches, interviews and news releases. Fact Check is similar to Politifact in their coverage and they provide excellent details. The only drawback is they lack the simplicity of Politifact.
- 3. Lead Stories- is a fact checker and hoax/rumor debunker that uses the International Fact-Checking Network fact-checkers' code of principles as a guide for all fact checking. What separates them is the use of a specific engine called the Trendolizer, which tracks story trends that allows Lead Stories to quickly debunk fake news before it becomes viral. They are often the first to debunk outrageous claims.
- 4. Science Feedback- is an IFCN fact checker that consists of two seperate websites, Climate Feedback, which reviews climate related claims and Health Feedback, which reviews health and medical claims. Each fact checker holds a Ph.D. and has recently published articles in top-tier peerreviewed science journals. This is by far the best fact checker for science related claims.

Additional Resources - Political Funding

Open Secrets— Open Secrets is a nonpartisan, independent and nonprofit, run by the Center for Responsive Politics, which is the nation's premier research group tracking money in U.S. politics and its effect on elections and public policy. Open Secrets is by far the best source for discovering how much and where candidates get their money. They also track lobbying groups and whom they are funding.

The Sunlight Foundation— a national, nonpartisan, nonprofit organization that uses the tools of civic tech, open data, policy analysis and journalism to make our government and politics more accountable and transparent to all. Sunlight primarily focuses on money's role in politics.
