Sewers: No report

Parks: Humke reported that the parks are being mowed. Thomassen moved and was seconded by Norman to purchase a tree for up to \$300 from Earl May to be planted in the park this fall. Motion carried 3-0.

Tree Steward: Fouts reported that she approved a resident's request to take down a dead tree. Also, DW Tree Service will be cutting down a dead tree in the park this fall.

Storm Sewers: Norman met with Jack Suttek from the Newton School regarding the storm sewer and road repairs on Thomas Jefferson. The school agreed to pay \$8,350 for the work behind the curb. Humke moved and was seconded by Norman to approve Jasper Construction's quote for roadway repairs to Thomas Jefferson Drive including the optional items of rip rap and storm sewer pipe for a total of \$27,690 with \$10,000 being paid out of the Road Use Tax Fund and the remaining to be paid out of the Local Option Sales Tax Fund. Motion carried 3-0.

Norman also asks residents to watch the storm sewers and help in the removal of leaves this fall to keep the drains open.
