Snohomish County USBC Youth Tournament Rules

1. USBC Youth Division rules and regulations will govern the tournament. USBC Youth division code will be enforced: All entrants must be eligible under USBC Rule 400.
2. Entry Fee will be \$25.00 per person/per event. Bowling expenses & lineage \$10.00 and Scholarships \$15.00.
3. Classifications are as follows; (According to Average)

Teams

- AA 680 & Over
- A 600 – 679
- B 599 & Under

Teams: All teams shall be composed of 4 members: mixed entries will be allowed and classified according to average. All entries must list and pay for four members. No partial teams accepted. No team member may switch teams unless the team he/she comes from is dissolved.

4. **Handicap:** Handicap will be based on 100% of 210.
5. **Payment:** No entry will be accepted unless accompanied by the full amount due on entry and made payable to Snohomish County USBC.
6. **Entry Dates:** All entries must be postmarked no later than November 27, 2019 and include full payment or they will not be accepted. Returned checks shall be subject to a \$35.00 service charge.
7. **Check In:** The captain must check in all teams one-half hour prior to start of the squad.
8. **Line Up:** Tournament entrants bowl in the order in which the names appear on the entry form.
9. **Entering Average:** The average to be used for this tournament will be in the order of:
 - a. Highest average as of 2018/19 season for 21 games or more. If none
 - b. Highest average from previous winter season for 21 games or more. If none
 - c. Highest average with 9 games or more as of November 31, 2019. If none
 - d. Highest current average with minimum of 9 games at the time of competition. If none.
 - e. Bowler will bowl scratch-210
10. **Substitutes:** Snohomish County USBC will not be responsible for filling vacant positions.
11. **Coaching:** Coaching will not be allowed in the settee area during tournament.
12. **Awards:** one out every five (5) entries or major fraction thereof will receive (scholarships)
13. **Conduct:** (a) No use of tobacco products or consumption of alcoholic beverages (b) No use of profane language or gestures (c) Bowlers shall conduct themselves in a courteous manner. (d) No gambling or pull tab playing during tournament play (e) no sharing of bowling equipment during the same squad.
14. **Clothing/Equipment Guidelines:** All bowlers must wear suitable and properly fitted attire. No hats, clothing/equipment advertising alcohol/tobacco products, no offensive or suggestive shirts and no shorts allowed except skorts. No sweats or spandex. No baggy pants or shorts. Tournament official will have final say on questionable attire. Participants will not be allowed to bowl unless properly attired.
15. **Protests:** Appeal or protest regarding tournament scores shall be made in writing to tournament management within 48 hours. Tournament official decides disputes occurring on the lanes.
16. **Spectator Conduct:** No flash or lighted video cameras will be allowed once tournament play begins. Alcohol consumption behind the participants is not allowed.
17. Under the direction of the tournament management, there will be confirmations e- mailed only for this tournament if you provide an e-mail address. If there is no availability for the times that you selected you will be notified by phone that a change will need to be made. Otherwise you will be scheduled for the dates and times that you selected.
18. **Refund dead line:** When an alternate time other than the requested has been assigned and the entrant has been notified of the new time, the entrant has two weeks from post mark date on confirmation form to refuse the alternate time. Entry fees shall not be refunded after that time. (USBC Rule 314).



Total entry fee must be forwarded with entry form. Remit by check or money order. Make checks payable to SCUSBC USBC. There will be a \$35 fee on all returned checks (Rule 6).
