

**MAPLE CREEK TOWN BOARD MEETING  
TOWN HALL W10388 COUNTY ROAD W  
MAY 22, 2022 2:00 PM**

**Call to order and Pledge of Allegiance**

Chairperson Griffin called the May 22, 2022 Maple Creek Town Board meeting to order at 2:00 p.m. and led the Pledge of Allegiance.

**Verify open meeting notices, roll call, approval of agenda order (stands as is unless motion for change)**

The agenda for these minutes was posted at the three Town posting boards on Wednesday, May 18, 2022.

**Specific matters for discussion and possible action:**

Roads:

1) Meeting on Saturday, May 14<sup>th</sup> with Chad Johnson. Chairperson Griffin report.

- Chad Johnson told Chairperson Griffin that on the County's proposal for Buboltz Road, we could get away with 4 inches of 1 ¼ inch gravel prior to pulverizing instead of 6 inches. The total County proposal is \$224,000; reclaim, shape and shoulder=\$120,000 and overlay the same mile right away with 4-LT-HMA 12.5 is an additional \$104,000. Adding 6 inches of gravel prior to pulverizing is an additional \$56,000.
- Finger Road should be pulverized and repaved, in the next 1-2 years.
- Schweitzer Road-keep ahead of the center crack-chip seal in 1-2 years.
- Corner on Spurr Road-grater patch until a road redo; also there is brush covering the bridge signs.
- Chairperson Griffin will contact Chad Korth from the City of New London regarding the Hintzke Road culvert.
- Chairperson Griffin was contacted by Sugar Creek Farm about putting manure pipes over Hoffman Road possibly on Friday. They will have to get road closure signs from the County and will be billed directly by the County. The signs need to be removed by Friday night. This will be on the June agenda.

Griffin made a motion, seconded by Knapp to hire Jim Young to cut the brush by the bridge on Spurr Road. Ayes 2, Opposed 0, Abstain 1. MOTION CARRIED.

Knapp made a motion, seconded by Griffin to have the County Highway Department grader patch the corner on Spurr Road just north of the bridge. Ayes 3, Opposed 0, Abstain 0. MOTION CARRIED. Chairperson Griffin will contact Chad Johnson.

2) Crackfilling update

Supervisor Knapp contacted Crack Fill Service to do the crackfilling with a cap of \$20,000. The clerk stated that we need to sign a contract and have a copy of their insurance before the work starts. Supervisor Knapp will contact them.

3) Buboltz Road—Bid project

Supervisor Knapp obtained a proposal from MCC, Inc. regarding the Buboltz Road project. Ian Murphy from MCC, Inc., suggested bidding the job by the square yard, not by the mile. Also, Supervisor Knapp suggests that no additional gravel should be put down prior to pulverizing. After more discussion, Knapp made a motion, seconded by Griffin to put out to bids a mile of Buboltz Road from County Road WW to Hoffman Road with the bid opening on Monday, June 20, 2022 at 7:00 p.m. Ayes 3, Opposed 0, Abstain 0. MOTION CARRIED. The clerk will put together the bid announcement and the specification sheet using the details from the MCC, Inc. proposal which was modified by the Board and get it in the Post Crescent. The Board would like a bid list to include: Badger Highway, MCC, Inc. and Northeast Asphalt.
