City Council Minutes

June 6<sup>th</sup>, 2016

The City Council of the City of New Munich met in session at 6:35 p.m., in the City Hall. Jim Poepping, Dan Krueger, Shawn Duevel, Pat Nathe and Ron Doll were present.
