There being a quorum, Mayor Simmons called the meeting of the Vienna City Council to order at 6:36 p.m.

Alderman Tuey made a motion to approve the Omnibus Consent Agenda consisting of the June 20, 2018 City Council Meeting Minutes, the Warrant (\$55,679.96), and the May Treasurer's Report. Alderman Riddle seconded the motion. Roll call: **Hill-yes, Riddle-yes, Myrick- yes, Owen-yes, Racey-yes, and Tuey- yes. Motion carried.**

NEW BUSINESS

Alderman Owen made a motion to Authorize and Approve General Funds to assist the JCYL with ballpark project expenses for installation of a wireless scoreboard (Field #4). The motion was seconded by Alderman Hill. Roll call: **Hill-yes, Riddle-yes, Myrick- yes, Owen-yes,**

Racey-yes, and Tuey-yes. Motion carried.

Ernie Henshaw and Gary Brumley both spoke on behalf of the Board of County Commissioners expressing their appreciation for the City's donation of (\$30,000.00 TIF Funds) towards demolition costs for the new county complex project.

CITY ELECTED AND APPOINTED OFFICIALS

Mayor Simmons thanked the City Fire Dept for their hard work with the Fourth of July celebration display. Simmons briefly spoke of IGA grocery closing.

City Attorney Stratemeyer discussed amending the zoning ordinance as council had taken action for him to draw up the necessary paperwork to increase the zoning board's compensation. Stratemeyer briefly reminded council of Open Meeting Act rules.

Clerk Wright informed council the FY Audit had been scheduled tentatively for July 18th. Wright also discussed details of the upcoming Color Run to take place September 22, 2018.

City Supt Racey discussed several repairs needed at the water plant as well as recent lightning damage to the water tower box which is crucial for operations. Racey reviewed the city ordinance for meters as a resident had been tampering with the shut off valve. Racey said the skid steer had been repaired and was running.

Treasurer Meyer commented on received revenue for the Police Dept from the city's recently passed towing ordinance.


Alderman Tuey expressed appreciation for the Public Works Dept.


Alderman Riddle briefly mentioned a stop sign that could be removed on property off of North 4th as in the past it had been a lane which no longer exists.
