- Please include the bylaws cover sheet when mailing bylaws and complete the information at the top of form which includes the person sending the bylaws, address, telephone number and e-mail address. (A copy of the cover sheet was included in the package received by the SEC).
- When a local auxiliary submits bylaws or amendments to the Department Parliamentarian for approval, one (1) copy of the minutes shall include the amendments. A separate sheet of the amendments indicating where the membership voted to adopt or a copy of the bylaws highlighted where changed, will be acceptable. Also, three (3) signed copies of the bylaws signed and dated by the President and Parliamentarian (if appointed) must be submitted to the Department Parliamentarian.
- There are three (3) forms of membership: Annual, Life and Member At Large. Honorary Members are not a form of membership for eligible members.
- Your bylaws are due three (3) years from the signature date of the Department Parliamentarian.
