The Columbus County Partnership for Children Smart Start agency is now accepting applications for the Professional Development Education Award. This award is available for teachers, directors, and family child care providers who are:

- Working in a NCDCDEE licensed child care facility serving children age's birth to five in Columbus County.
(Note: employees serving only school-age children are not eligible)

AND

- Currently enrolled in at least one class included in an Early Childhood Degree program. Applicants must have declared their major as Early Childhood Associate or Bachelor Degree (or closely related degree such as Education of Young Children, Birth – Kindergarten Education, or Child Development). Note: This means that you are not in the special credit, credential, certificate, or diploma program. If you are unsure of your status, please call your college's admissions office.

Applicants must submit:

- A completed application.
- An official transcript indicating semester ECE coursework.

Recipients may be required to:

- Maintain employment at the same facility throughout the semester.
- Remain enrolled in the Early Childhood Degree program throughout the semester.
- Provide a copy of recently awarded degree if applicable.

Additional Information:

- Awards will only be provided for each course completed with a **grade of "C" or higher**.
- Checks will be issued after the semester has ended and all documentation has been received and approved.
- Interested participants must reapply each semester to be eligible. The number of recipients may vary each semester, depending on the amount of Smart Start funding available. All awards are contingent upon available funding.
