The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jordan Schmiesing, Kurt Thelen, Ron Doll and Sandy Zierden were present.

On a motion by Jordan Schmiesing, seconded by Ron Doll and carried the minutes from August 7, 2023 were approved.

Fire Chief was present—5 medical calls. EMR refresher – needs to schedule. 2 chiefs going to the chiefs convention Oct 18-21 in Duluth. Need a place for the fire trucks for 6 days while pouring the cement in front of the fire doors.

Waste/Water Operator, Jon was present—#6 well fail-Wheels water came and fixed it now back up and running at 36 hours of being down. Jon and Justin want to clean out the shed across from the well house, will work on over the next couple of months. Ordered 5 new meters.

Building Permits – Dan Pasanen-Greenhouse 10'x12', anchor to cement blocks, polycarbonate material. Brian and Josie Thull-Paint post office, north and west side of building, light grey, fix east cement step from main street service door.

Fireman's donation will be given in September to the Relief association.

Gerald and Darlene Revermann are going to start checking on the bathrooms at the park.

2 trees in the park need to come down by the new veterans memorial. One is into the light as well. Sandy Zierden made motion to have them removed, 2nd by Ron Doll, Motion carried.

Jordan Schmiesing made a motion to approve Budget Resolution 9-23-A, Sandy Zierden 2nd. Motion carried.

Had a complaint about firearms within city limits. Will check with city attorney to see what her recommendation is on this matter and what other cities have for ordinances within their city limits.

Susan the city attorney got back about the CUP agreement with Randy Rasmussen. She will be sending out a letter to Randy. He will have 60 days and will need to let the council know by the November 6th meeting.

Small Cities Development Program – Sandy Zierden made a motion to move forward with the small cities development program, 2nd by Ron Doll, Motion carried. Kurt will get the agreement signed and back to Dustin to get the process started. This is potentially a great opportunity for residents in town if they need their water lines to their homes replaced to be done through a grant with DEED. Look for more information to be coming to your mailboxes.

The Lions would like to see 2 new speed signs at each end of town. Mayor Kurt said they are about \$3200.00 a sign. Kurt also has an anonymous donor who would like to donate \$500.00 towards the signs.
