Diane Robinson and Donna Gay of the Administrative Office of the Court will present a CLE on new procedures effective 1/1/2017.

Diane Robinson is the director of research and justice statistics at the Administrative Office of the Courts. Diane previously worked in the court system in Arkansas as state director of the CASA program and as the coordinator of the juvenile Court Improvement Program. A desire to see more evidence-based policy and court practice led her to pursue a PhD in Health Systems and Services Research at UAMS. She also has degrees from Indiana University and Texas A&M University, is a returned Peace Corps Volunteer, and is on the Conway School board.

Donna Gay is a staff attorney with the Ad-

ministrative Office of the Courts, the administrative arm of the Arkansas Supreme Court. She works with the Domestic Relations and Probate Divisions of Circuit Court, staffs the Supreme Court Committee on Child Support, works with the Chief Justice on assignments of special judges in circuit and district courts, and works with the Domestic Relations Attorney Ad Litem program.
