APPROVE AND OR DISCUSS ACCEPTING EMERGENCY MANAGEMENT PERFORMANCE GRANT FOR \$24,946 FOR 2017 FORD F-150 XL SUPER CAB 4X4 PICKUP.

Porter present and explained grant and what it's for. Short questioned dual use of vehicle. Porter explained grant pays all operating expenses. Short asked if sewer guys can use it. Porter stated he could help them out with it in emergency or disaster type situations but could not just hand it over. This would be the vehicle Porter uses day to day with school/OEM/patrolling. Short asked if Porter could hand it over to Police. Porter stated no, but can assist in a disaster situation. Gourley stated it is the same arrangement as with the old vehicle.

Motion by Miller to accept the \$24,946 Emergency Management Performance grant. Second Bowman. Discussion: none.

APPROVE BID FOR 2017 FORD F-150 XL SUPER CAB 4X4 PICKUP.

Porter obtained four bids. Don Vance Ford was lowest bid for \$24,946.

Porter passed out new bid for same vehicle but with upgrades such as power windows, power locks and greater towing assets. These can be safety issues when transporting. Porter spoke with City Treasurer about EM budget. EM still has a \$1000 Walmart designated grant that could be used towards this purchase. Difference in totals would be \$1854. Porter stated this is time sensitive because all purchases must be received and paid by June 1. Miller stated he had no problem with the upgrade. Short questioned phone bids. Porter to bring two more bids to Board. Motion by Miller to approve bid no more than \$27,800 for 2017 Ford F-150 XL super cab 4x4 pickup with two additional bids to be brought to Board.
