Currently enrolled families paying tuition **in full** on or before June 15, 2019, will receive a 5% discount. Newly enrolled families paying tuition **in full** on or before the first day of classes of the 2019-2020 academic school year will receive a 5% discount.

Note: Your child **MUST BE** three years of age prior to September 1st to be considered for our K3 class; your child **MUST BE** four years of age prior to September 1st to be considered for our K4 class. There will be **NO NEGOTIATING** this matter. Additionally, any child registered must be completely toilet trained by the first day of school.

Jefferson Davis Academy is a private institution . I understand the school has the right to refuse admittance to this institution, terminate enrollment, withhold report cards or transcripts, refuse graduation, and/or deny transfer of credits or records for any student whose financial account is delinquent, or who violates any of the school rules and regulations.

I have read and accept the terms and conditions set forth in the enrollment contract and agree to full compliance of this binding agreement. I understand it is my responsibility, as well as my child's, to read the 2019-2020 Student Handbook and abide by all rules and consequences set forth by Jefferson Davis Academy. The Board of Trustees shall set forth the by-laws, rules, regulations and operating policies of Jefferson Davis Academy and all decisions by the Board of Trustees shall be final.

_____ I understand that all contractual commitments must be kept in good financial standing. I have read and understand that tuition payments are due on the first of each month and considered past due on the 16th of each month. A late fee of \$100 per family will be charged on the 16th of each month beginning in June of 2019. Jefferson Davis Academy reserves the right to dismiss any student whose monthly tuition is 30 days past due. TUITION NOT PAID BY THE FIRST DAY OF THE FOLLOWING MONTH WILL RESULT IN THE CHILD(REN) BEING REMOVED FROM SCHOOL UNTIL PAST DUE TUITION IS PAID IN FULL.

_____ I understand that Jefferson Davis Academy reserves the right to initiate legal proceedings, at its discretion, for collection of tuition past due for thirty or more days. All report cards and transcripts will be held if tuition has not been received in a timely manner.

_____ I understand that anyone seeking to be released from this contract must submit a letter to the Board of Directors indicating their desire to terminate the contract. The fees associated with terminating the contract are as follows and must be paid prior to JDA agreeing to terminate the contract.

- \$2,000 for the first child
- \$1,500 for the second child
- \$1,000 for the third child
- \$ 0 for the fourth child, although all other unpaid contractual fees must be paid

_____ I understand this contract may be terminated only in the event that the residence of the child(ren) enrolled should move from the areas served by JDA which include the counties of Barnwell, Bamberg, Allendale, Aiken, Orangeburg, Colleton and Hampton.

_____ I understand that in the event that a child is absent by reason of illness, suspension or expulsion, or for any reason, the obligation to pay shall continue unless released by the Board of Directors.

_____ I understand JDA has the right and prerogative to determine the correct class as well as grade level at which each child should be assigned. All new students will be given a standardized aptitude test for admission to Jefferson Davis Academy.

_____ I understand that each new student will be REQUIRED to have the following:

- Copy of SC immunization record
- Birth Certificate
- Social Security Card

_____ I understand all students need to be in their homerooms classes NO LATER than 7:45 a.m.; the accumulation of 4 tardies will result in one day of Friday detention.
