## Pool closures

Every year we are repairing the pool which costs thousands of dollars. This doesn't include the cost of heating the pool during the winter. This year we are going to let the people vote as to whether we keep the pool open or closed during the winter. When we send out the ballots for the election, we will include the pool closure on the ballot. It will be up to the people not the Board. We will also include the hot tub on the ballot. It is going to cost \$25,000 to \$30,000 to put an inground hot tub. If you opt out it will keep cost down and dues won't need to be raised.

Trees have been a concern. We have been taking them out. Eventually these trees will be gone due to issues. The Board has put funds together to begin replacing trees. Zamzow's has been contacted for information. Considering buying a large group of trees to lower cost. Post on web to see if others would be interested in getting trees for their lot at a lower cost if interested.
