4/30/2018

Sgt. Warner and Deputy Weekley responded to SR 379 & Harper Road in reference to a tractor-trailer that struck the bridge at the intersection. No injuries were reported and all information was gathered for a report to be completed. The county engineer was contacted in reference to the damage to the bridge and will be evaluated further.

Deputy Schumerman and Deputy Blamble responded to Greenhilll Road in reference animals running at large. The dog's owner was identified as Carl Ayers. While on the scene both deputy's spoke with Craig Ayers, Brittnay Thomas, James Baranich and Michellle Rosenlieb. There was a verbal altercation between Craig, James as well as Brittnay and Michele. 5/1/2018

5/3/2018

admitted to smoking crystal meth and driving the vehicle to this location. Poole was taken into custody and submitted to a voluntary urine analysis, pending results. He was released into the custody of a friend.
