- ✓ Neighbourhood location
- ✓ Lot size
- ✓ Resident experience with hens
- ✓ Attendance at the Backyard Hens 101 session at the next available date
- ✓ Good neighbour considerations

By signing this application form you are applying to be a participant in the Urban Backyard Hens Pilot Project Program. If you are approved to participate, than you agree to conform to the " Urban Backyard Hens Pilot Program Participant Guidelines" for the duration of the program. You are aware that if your hens impact your neighbours and a complaint is filed, the town will notify you of the concerns and ask that you endeavour to mitigate any impacts associated with keeping your hens. Failing to comply with any of the regulations set out in the "Participants Guidelines" can result in being removed from the program.
