INFORMATION REQUIRED:

- 1. Exterior Painting/Siding: If you are changing house or trim color, attach a copy of your color choice(s) to this form.
- **2. Addition** of a pool, shed, fence, deck, porch, patio, shed, playset, etc. Draw location of improvement on sketch and give dimensions including height, length, width, and distance from each property line. List construction materials to be used. Please note: Chain and wire fences are not allowed.
- **3. Room additions:** All the above items plus elevation and side view; show windows, doors, etc. Indicate all construction materials for exterior walls, roof, etc.
