To the Sherburn and Welcome City Councils,

The department logged 170 calls for the month of March. This brought the total for the year to 369. By comparison, the department stood at 369 in 2016 and 353 in 2015 for the same reporting period.

Response time average for the month was 5 minutes and 30 seconds. This is an acceptable response time, however, it is higher than our normal average.

The web-site had 1,318 visits during the month of February. This is slightly lower than normal, however, February is a short month. The traffic is still very high for the web-site on a month by month basis.

The clean-up dates have been set in both communities, so the department will begin conducting the city tours in the early part of April. Red tag warnings will be issued at the completion to those properties in violation and the owners will be given until the week after clean-up days are completed. Any violations still existing at that time will be cited. My hope is to have all violations corrected by the end of May at the latest including those who have to appear in court.
