Official Contest Rules

Sweepstakes Period:

SMG Living Ageless Remodeling's "Bathwraps Shower Giveaway" ("Sweepstakes") begins at 9:00 a.m. (Eastern Standard Time – EST) on August 22, 2018 and ends at 7:00 pm. (EST) on March 31, 2019.

How to Enter:

You may enter the Sweepstakes by filling out the Bathwraps Shower Giveaway Registration Form in person or online at www.smglivingaip.com. Applicants must complete registration during the Sweepstakes Period to be considered for the drawing. No more than one (1) entry per household.

Eligibility:
