For the reasons as stated on the record,

IT IS ORDERED affirming the previous orders of the Honorable Judge Sanders' with respect to Receiver's Petition No. 41: Petition to Approve First Interim Distribution to Creditors, filed November 8, 2017. Any monies that would have been distributed to Brinkman Family Trust and Hafiz shall be withheld until their claims in the probate case are resolved.

IT IS FURTHER ORDERED holding in abeyance Petition No. 47 Request to Direct Receiver to Honor Subrogation Rights Re: Any Payments Made by Chittick Estate to Brinkman and Hafiz filed December 8, 2017, until Probate Court has decided Chittick Estate's Motion for Summary Judgment.

If Probate Court grants the Motion for Summary Judgment, then the issue of subrogation becomes moot. If Probate Court denies the Motion for Summary Judgment, then this Court may further hold in abeyance the ruling on Petition No. 47 until Probate Court decides whether (1) Brinkman Family Trust and Hafiz proved their claims, and (2) if the claims are proved, whether the Chittick Estate has any money to pay on the claims for Brinkman Family Trust and Hafiz to execute on the claims. At that point is when the issue of subrogation becomes ripe for this Court to decide.

The Court requests that the parties advise this Court once a ruling has been made in Probate Court.
