SSEP is a nonprofit corporation formed to promote diabetes and pregnancy guidelines through education. The guidelines are based on the highly successful Sweet Success model of care.

SSEP, in collaboration with Sweet Success and Sweet Success Express, is dedicated to improving the care of women with diabetes prior to and during pregnancy and promote future health for mothers, babies and families. The SSEP Board of Directors oversee the management of the assets to ensure that the purposes of SSEP are carried out.
