AN ORDINANCE

Adopting and Amending ordinance No. 2018-64 (Permanent 2019 Appropriations) by appropriating from unappropriated funds in the General Fund, City Clean Up Fund, Sewer Fund, and Fire Insurance Trust Fund and declaring an emergency.

BE IT ORDAINED by the Council of the City of Fostoria, Seneca, Hancock, and Wood Counties, Ohio:

SECTION 1: That ordinance No. 2018-64 (Permanent 2019 Appropriations) passed December 18, 2018, be, and the same is hereby amended as delineated in the following sections:

SECTION 2: That Thirty Thousand Dollars (\$30,000) be appropriated from unappropriated funds to 101-450-531700 General Fund/Community Environment-Zoning/Contractual Services-Other Contractual Services.

SECTION 3: That Twenty Thousand Dollars (\$20,000) be appropriated from unappropriated funds to 248-499-56860 City Clean Up Fund/Community Environment-Community Development/Other-Refunds.

SECTION 4: That Fifty Thousand Dollars (\$50,000) be appropriated from unappropriated funds to 520-520-531700 Sewer Fund/Basic Utility-WWTP/Contractual Services-Other Contractual Services.

SECTION 5: That Fifteen Thousand Dollars (\$15,000) be appropriated from unappropriated funds to 708-120-561860 Fire Insurance Trust Fund/Security of Persons and Property-Fire/Other-Refunds.

SECTION 6: That this ordinance shall be published in accordance with applicable Ohio Law.

SECTION 7: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 8: That in order to preserve the public peace, health, safety and welfare of the City of Fostoria and its inhabitants, and in order to make the appropriation adjustments in the Permanent 2019 appropriations without delay to meet pending obligations, this measure is determined to be an emergency ordinance and shall take effect at the earliest time allowed by law after its passage.

THEREFORE, upon the affirmative vote of two-thirds (2/3) of all members elected to Council, and signature by Mayor, this ordinance shall take immediate force and effect.
