

**TOWNSHIP OF HAMPTON
ORDINANCE**

**SPECIAL EMERGENCY APPROPRIATION PURSUANT
TO N.J.S.A. 40A:4-53 FOR THE
PURPOSE OF PREPARATION AND EXECUTION TO COVER EXPENSES
RELATED TO CONTRACTUAL OBLIGATIONS FOR REVALUATION
SERVICES AND OTHER RELATED COSTS AS A COMPONENT TO
COMPLETE A PROGRAM OF REASSESSMENT OF REAL PROPERTY**

WHEREAS, it has been found necessary to make an Emergency Appropriation to meet certain extraordinary expenses incurred, or to be incurred for the preparation and execution to cover expenses related to Contractual obligations for Revaluation Services and other related costs as a component to complete a program of reassessment of real property for the use of the local assessor; and,

WHEREAS, N.J.S.A. 40A:53 provides that it shall be lawful to make such appropriation, which appropriation and/or the "special emergency notes" issued to finance the same shall be provided for in succeeding annual budgets by the inclusion of an appropriation of at least one-fifth of the amount authorized pursuant to this act.

WHEREAS, the cost of said reassessment program is \$210,000

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Hampton, in the County of Sussex, that in accordance with the provisions of N.J.S.A. 40A:4-55:

1. Pursuant to N.J.S.A 40A:4-53, the sum of \$210,000 is hereby appropriated for the conducting of a Township-Wide Reassessment Program and same shall be deemed a Special Emergency Appropriation as defined and provided for in N.J.S.A. 40A:4-55.
2. That said emergency appropriation shall be provided for in the budgets of the next succeeding years by the inclusion of not less than \$ 42,000 in each of the next succeeding annual budgets.
3. To the extent that any previous ordinance or resolution is inconstant herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.
4. A copy of this ordinance shall be filed with the Director of the Division of Local Government Services.
5. This ordinance shall take effect upon passage and publication as required by law.
