Peggy Gandy Lamb, longtime legal professional in Tyler, passed away on May 27, 2021 in Tyler. She is survived by her husband of 52 years, Johnnie Lamb, two children, numerous grandchildren, and many other relatives. She is also survived by many friends and other legal professionals in the East Texas area, a great many of whom she took under her wing and helped train in the legal field.

She most recently worked for Gillen & Gillen (14 years) in Tyler as a real estate expert and closer. Peggy loved the legal profession and always wanted to work. She also always wanted to help others and would pitch in any time she could.

Peggy was diagnosed with pancreatic cancer a little over two years ago, which she diligently fought with all tools available. After each major treatment, she would be back at the office as soon as possible. The first time she went into the hospital, she took her computer and as many files as she could and worked from her hospital bed. Working kept her spirits up. Her doctor finally told her she needed to conserve her strength for recovery from the procedures she went through and the day she was told that was a very difficult day for her.

Peggy had been a major member and contributor to local legal professional associations in Tyler for most of her long career. She was a long-time member and supporter of TAALP and its predecessor associations.

We will miss her, her always cheerful and upbeat attitude, her knowledge, and willingness to help others.

Having experienced terrifying events such as snipers shooting only blocks away from my school, president fleeing his own country, losing my best friend, and witnessing the tragedy of a country abused by power-hungry leaders, I began to dream of living in a place that values the rights and well-being of the people, a country where my family and I could feel safe and prosper. I began to dream of America; and when that dream was realized, I became determined to take advantage of the boundless opportunities that exist here, that I might also become someone who can grant opportunity, stability, and growth to others.

The pain of losing my older brother and best friend quickly changed me from the little brother I had been prior to Pasha's death. Rather than succumb to a depression that threatened to overwhelm me, I made the choice to honor Pasha's memory by striving to achieve the maximum potential God has bestowed upon me. I determined to value every moment of my life, to have a positive impact on my family, friends, and community. Therefore, when The Brook Hill School offered me a full scholarship to complete the academic track my brother never would, I accepted with a grateful and resolute heart.

Now, my goal and definite purpose in life is to become an Economist and Immigration/Corporation Lawyer through which I will be able to affect policies, grant new opportunities, provide stability and growth for the economy, and protect the rights and well-being of the people especially those of immigrants. All this is done to make sure that the people in this country, America, won't have to experience the horrifying events and tragedies that I experienced back in Ukraine.

The knowledge of the law, in particular immigration/corporate law, is crucial to the individual's as well as the country's well-being and advancement. It influences the decisions one must make regarding work, leisure, investment, etc., and it provides the information necessary for governments to make policy decisions that maximize economic growth. This is exactly what fuels my interest in becoming a lawyer – the excitement of navigating challenges and exploring novel solutions to discover the most rewarding course, for both the individual and for larger organizations. The abundant opportunities that come with becoming a lawyer are too great to miss. As lawyers are positioned in a way that lets them protect versatile groups, individuals, companies, and those without a voice – such as children or even our planet. Moreover, a lawyer can expand the public good, influence policies, and even have an impact on the way the world functions. Thus becoming a lawyer is a dream I will achieve to help others attain security, satisfaction, and overall higher well-being not for the good of myself, but for the good of others.

The Unforeseen

It was not long ago that most of the world knew very little about my home country; but in the last few years, the events in Ukraine have shocked the world into acknowledging its existence. The people from my country have revolted against corruption and abuse of power, causing disorder, and it has taken this sort of negative action to call the world's attention to my home. However, this is not only the story of my country; it is also the story of my life. A flower endures the rains in order to flourish and blossom in the sunlight. In the same manner, I have realized that the overwhelming downpours I have and will continue to endure are necessary for my growth.

Pasha Zapolskyy was not only my older brother, but also my closest friend and an extraordinary example for me. In March of 2015, he was a senior international student at The Brook Hill School in Bullard, Texas, excitedly looking forward to graduation. However, just weeks before Pasha's graduation would occur, an intoxicated driver took his life from him at only seventeen years old. The horrifying news spread rapidly, soon reaching even our social networks in Ukraine; and while this information seemed at first surreal, as if a dream, there was no escaping it.

The first time my family and I visited the United States was to attend Pasha's funeral. The pain of losing my older brother and best friend quickly changed me from the little brother I had been prior to Pasha's death. I made a choice to honor Pasha's memory by striving to achieve the maximum potential God has bestowed upon me. I determined to value every moment of my life that I may have a positive impact on my family, friends, community, and everyone I encounter. Additionally, I realized I would have to change my attitude to accomplish this goal. Anything can be taken from a person save one thing: attitude. We are often unable to change our circumstances; yet if we have an attitude of gratitude, we can change the final outcome of those circumstances.

After Pasha's death, The Brook Hill School offered me the opportunity to complete the academic path my brother was not able to finish, by granting me full tuition. With a grateful heart, I decided to take on this academic challenge and to persevere through the language barrier and cultural differences. The chance to study in the United States pushed me to learn, explore, grow, and, most importantly, to serve others. My effort was fueled by the fact that I have never lost sight of the true cost of this opportunity – the highest price, the loss of my brother.

As a student in this country, I have experienced both great opportunities and great challenges that have shaped me into the person I am today. Despite many hardships, I am successfully completing Advanced Placement courses, and I am a member of the National Honor Society as well as a dedicated varsity and club soccer player. I enthusiastically volunteer at my church and in the community and

work as a math tutor. Recently, I have also been enjoying books on successful individuals, eagerly consuming the life lessons they have to offer. I have begun to imagine life as similar to a soccer game. In soccer, we work to overcome obstacles, acquire scrapes and bruises, gain skills from experience, and are motivated by the support and encouragement of those who cheer us on; such is life.

Through the anguish of my brother's death, I have learned that though I cannot predict what will happen tomorrow, I *can* choose how I live my life today, and I can choose to live courageously. As Winston Churchill, former Prime Minister of the United Kingdom, once said: "Success is not final, failure is not fatal: it is the courage to continue that counts."



in place and it has brought so much enjoyment to my life, not to mention the extra income to our family. I also like to travel with my family and girlfriends...Beach vacations call my name!


