JESUIT HIGH SCHOOL COMPETES IN SPITE OF ADVERSITY

The young gentlemen from **Jesuit High of New Orleans** are all smiles as they overcame great odds to compete in the 2005-2006 National Mock Trial Competitions. The team finished 11th out of 44 teams at the National High School Mock Trial Championships in



Oklahoma City on May 13, 2006. Jesuit defeated Utah in the first round, lost to South Carolina in the second round, defeated last year's national runner-up Wisconsin in the 3rd round and won its 4th round matchup against Florida to finish with a 3-1 record. Jesuit matched the previous high finish held by Baton Rouge Magnet School and Caddo Magnet.

The Jesuit group was recognized as the team that had to overcome the most adversity just to compete at Nationals. Next year's National Championships will be held in Dallas, Texas.
