

July Virtual Workshop - Sarah Bond

Scrappy String Diamonds with Sarah Bond



Stuck in the house with nothing to do? Seeing Red? Feeling Blue? We've got something fun to do!

Join me on Zoom! with a project designed to use up your scraps, spark your creativity, and restore your sewing mojo. This variation on a traditional string quilt encourages you to dig into your scrap bin and find those beautiful bits you couldn't bear to throw out. Combine them on a paper or muslin foundation to create jaunty rows of diamonds in any color combination you choose.

I'll provide the Pattern and the Zoom Login The pattern offers 2 sizes: Baby or Throw size: 38 X 60

Larger size: 75 X 80



Materials:

Printer to print pattern and paper foundations.

Muslin if you prefer that to paper for your foundations Scraps. I can't say how many scraps you'll need, but I made these two quilts and really didn't notice any significant reduction in scrap mass.

Background Fabric.

2/3 yards each of 2 background fabrics for a total of 1 1/3 yards 1 ½ yards each of 2 background fabrics for a total of 3 yards.

Basic sewing supplies, sewing machine in good working order, paper scissors, maybe a glass of wine.



QUILTS IN THE MILL NEWS -- Change Means Opportunity

As you all know by now, our Quilts in the Mill show, scheduled for this October, has been postponed until 2022. The date change was approved by the membership at an emergency meeting on May 3. In this extraordinary time of pandemic, we are experiencing the truth of the phrase that "the **best laid plans** of mice and men often go awry."

But, as quilters, we know how to take scraps and turn them into things of beauty. Let's look at this unusual time as an opportunity.

We can use the additional time until the 14th biennial show to:

- Complete more quilts to exhibit at the show
- · Sew more minis for the mini quilt raffles
- Make many more than three (3) handsewn/handmade boutique items (each member's donation required by bylaws)
- Collect fabrics/notions/books etc. for Boutique

We will use this as an opportunity to explore new pandemic related safety measures. We will continue to discuss how to expand outreach to other age groups to widen our visitor base.

Raffle Quilt Opportunity:

The 14th biennial show raffle quilt, Southern Sunset, is completed and insured. A benefit of the additional two years before the show is that we gain at least an additional year to sell raffle tickets for this exceptional quilt.

As you know, raffle quilts are created and completed in the odd numbered year prior to a show. By the time is it appraised and a licensed raffle ticket sale begins, we have just around six months to sell raffle quilt tickets.

Because of the show date change, the raffle quilt is ready now for the 2022 show. We should keep to the schedule of creating a new raffle quilt in the odd number year, and so use 2021 to create a quilt for the 2024 show. This way, instead of only 6 months to sell raffle tickets, we can have over 12 months to sell tickets. As an example, tickets

can then be sold from October 2021 through October 2022, or whatever date we choose to start selling the tickets.

A wonderful suggestion made was that the guild plan a special event in 2021. The purpose of the event would be to "lounch" our roffle guilt with ticket sales beginning at the event. Free to the public, the guild would stage exhibits, domes

"launch" our raffle quilt, with ticket sales beginning at the event. Free to the public, the guild would stage exhibits, demos, and other enticements TBD. It would be held in the guild's meeting room at the Hunterdon County Complex. The public would be introduced to our show raffle quilt. Or this special event could be used for other purposes. Here we welcome any and all suggestions to develop this idea for the benefit of our guild.

Because we would have the raffle quilt a whole two year cycle before its designated show, we have the opportunity to show our quilt at more venues. We welcome members to make suggestions for other suitable fairs, community events, bazaars, etc., where we may obtain a table to show our quilt and sell raffle tickets.

Going forward, the quilt created in 2021 would be "launched" in 2023, a year before the 15th biennial show in 2024, and raffled at the 2024 show.

Raffle quilt licenses are issued for the calendar year, so we would need to purchase 2 consecutive years to cover fall to the next year's fall.

Do you have any suggestions or ideas for the show? Groups to contact to expand our attendee base? The "launch" event? Venues to sell tickets?

We ask the entire guild to help make a positive, beautiful patchwork out of the pieces we have been dealt.

Board Minutes from May 17, 2020

EXECUTIVE BOARD

President Ellen called the meeting to order at 5:33

A motion was made to approve minutes from the emergency meeting (the purpose of the meeting was to create a recommendation for the general membership concerning the date for the guild's 14th biennial Quilts in the Mill show.

The motion was made by Al and seconded by Andrea. The motion was passed unanimously pending the corrected spelling of Al Accettola's name.

Ellen will press to get a nominating committee formed at the Membership meeting tonight.

Vice President/Program-Cass G. Cass suggests that we move the June meeting to the 4th Sunday of the month permanently since it conflicts with Father's Day. So we'll meet June 28th this year. This information will be distributed at the Membership meeting tonight and put in the newsletter. Cass has been working on getting virtual workshops/lectures for upcoming meetings.

Treasurer-Andrea C. The Treasurer's Report was distributed to the board prior to the meeting. Andrea let Patty know a reimbursement check was coming this week.

Recording Secretary – OPEN-Cass taking minutes for May.

Corresponding Secretary- Claire C. No information to share but asked that people let her know if cards need to go out.

COMMITTEE REPORTS

Newsletter- Al A. Al suggested we list the vendors that would have come to the show in our newsletter so we can patronize them during this difficult time.

Show- Camille Q., Andrea C. Camille will speak about the show at the Membership meeting.

Web Presence – Cathie G. Website is updated. Cathie will try to put things of interest on social media.

Other Business: Venue Committee- Joan Lasota, Alice Sprenger, Cass Garner and headed by Patty Gertz. Patty explained that after the last show the committee was tasked to find out if there was a better place to have our next show. A document was distributed earlier to the board/membership highlighting pros and cons for 3 venues out

of about 30 that were investigated over more than a 12 month period. Those venues were the only 3 that met the criteria that was set. The 3 were the Mill, Del Val, and Raritan.

This information will likely need refreshing before the 2024 show but much of the data will be relevant and useful to a variety of people between now and then. Patty captured all of the information that was collected into a spreadsheet that will be in CHQ Google Docs repository for CHQ use.

We will have a more in-depth discussion closer to the 15th CHQ show. Patty will present information about the committee's findings at the Membership meeting.

Clarification of the purpose of the vote at the emergency meeting. This vote was simply to decide if we would do a show in 2021 or 2022. Everyone felt that doing it in 2022 would be best. One person disagreed during the membership vote.

Brielle inquired who had the appraisal for the raffle quilt and Cathie G. has it. Brielle has the quilt.

A motion was made by Andrea and was seconded by Al to adjourn at 6:23

MINIS IN THE MILL

One of the successful fundraisers held during our CHQ biennial quilt show has been a raffle of mini quilts

made by the guild members. The raffle is conducted in tricky-tray fashion, with the drawing on the

afternoon of the last day of the show. It's a great opportunity for members, other quilters and non-quilters to take a chance at taking home a small piece(s) of quilted art made by CHQ members.

In the past we've raffled 50-60 mini quilts per show.

Please consider making at least one Mini for our October Courthouse Quilters Guild Show.

Here are the rules for Mini construction:

1. Your Mini can represent any theme and can be traditional, modern or an art quilt, either from a pattern

or your own creation.

- 2. Your Mini can be as small as 6"x6" (minimum) or as large as 24"x24" (maximum).
- 3. No cheater cloth.
- 4. Your Mini can be machine or hand quilted; no tied quilts.
- 5. Your Mini should have a label with quilt title (optional), your name, county, state, date and Courthouse Quilters. That way the lucky winner will know all about their new quilt and who made it. It's not necessary to add a hanging sleeve.
- 6. Your Mini must be handed in by no later than the September meeting. This will give the committee time to photograph the Minis and finalize other details.

Minis can be given to Mary Rigby or Joan Lasota at any guild meeting. If you have any questions, please feel free to contact us.
