The board decided to remove the grant from the budget and the need for any fund balance to be used. The wanted line item 4027 (Travel expenses) to be increased to \$3000.00.

#### Update from Kurtz Stowers on a conversation he had with Frank McCrady, President/CEO, EMCID

No action was needed on this item. Kurtz stated that Mr. McCrady is a friend of the family. He is from Montgomery County. Kurtz wanted to check that the city has the maximum amount of sales taxation because the EDC can get a portion of the tax if its available. (The Shepherd EDC already gets a portion of the city sales tax and the city is at the max.) Mr. McCrady suggested a demographic survey. Mr. McCrady gave Kurtz some leads on possible grant funding: ED Association, CDBG and from the Railroad.

#### **Discuss and take action to Elect Officers**

Jody explained this should be happening every two years. The Board agreed on the following officer positions. Jody Cronin- President. Sherry Roberts- Vice President. Amanda Addison agreed to be the secretary and Mark Hamilton will hold the treasurer position. The next election should be in 2023 to align with budget times.
