OFFICIAL MINUTES OF THE REGULAR MEETING OF THE BOARD OF WESTON COUNTY COMMISSIONERS, WESTON COUNTY, WYOMING June 18, 2024

The regular meeting of the Weston County Board of Commissioners was called to order by Chairman Don Taylor at 9:00 a.m. at the Upton Town Hall. Commissioners Ed Wagoner, Nathan Todd, Garrett Borton and Vera Huber, and Clerk Becky Hadlock were present. Commissioner Borton opened the meeting with prayer, and Walter Sprague, reporter/photographer for the *News Letter Journal* led the Pledge of Allegiance.

APPROVAL OF AGENDA

Clerk Hadlock asked to add Weston County Public Health Cash Handling Policy to the Consent Agenda. Vice-Chairman Borton moved to approve the agenda as amended; seconded by Commissioner Huber. Carried.

ATTORNEY BUDGET ADJUSTMENT

Weston County Attorney Legal Assistant Brooke De La Rosa sent an email indicating a purchase for worry stones for \$24.99 was not approved through the VOCA Grant so this would need to be paid for out of the County Attorney Budget. Commissioner Wagoner moved to approve adjusting \$24.99 from 120.00.06.0193000.0624 to 100.00.06.0089000.0000; seconded by Commissioner Huber. Carried. The Board would like to have Attorney Stulken work on a letter addressing pre-authorization of purchases made when spending grant funds.

SHERIFF BUDGET ADJUSTMENT – BOARD'S SIGNATURE ON RESOLUTION 2024-16 AMENDMENT TO THE 2023-2024 BUDGET

Weston County Sheriff Deputy Dan Fields came before the Board to explain why a budget adjustment of \$8,393.43 was needed. Commissioner Todd moved to approve the Board's signature on Resolution 2024-16; seconded by Commissioner Wagoner. Carried.
