ASSUMPTION OF RISKS: I am aware that participation in sports, without limitation, offered by or associated with Fury Volleyball, exposes my child to many inherent risks. By engaging my child in these activities, I freely accept and fully assume all inherent risks, dangers, and hazards and the possibility of personal injury, death, property damage or loss resulting there from.

RELEASE OF LIABILITY WAIVER OF CLAIMS & INDEMNITY AGREEMENT: In consideration of Fury Volleyball providing my child with the opportunity to participate in their activities, permitting him/her the use of its equipment and the use of facilities, I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against Fury Volleyball, as well as their directors, officers, employees, agents, representatives, assigns and successors.

TO RELEASE Fury Volleyball and its affiliate programs, as well as all their directors, officers, employees, agents, representatives, assigns and successors from any and all liability for any loss, damage, injury or expense that I or my child may suffer as a result of his/her participation in activities and sports offered by Fury Volleyball; due to any cause whatsoever **INCLUDING NEGLIGENCE, BREACH OF CONTRACT, BREACH OF STATUTORY DUTY OF CARE, AND/OR BREACH OF THE OCCUPIER'S LIABILITY ACT, ON THE PART OF FURY VOLLEYBALL** as well as its directors, officers, employees, agents, representatives, assigns and successors

TO HOLD HARMLESS AND INDEMNIFY FURY VOLLEYBALL, and all their directors, officers, employees, agents, representatives, assigns and successors from any and all liability for any property damage or personal injury to any third party, resulting from my child's activities and his/her participation in the activities offered by or associated with Fury Volleyball.

PERSONAL INFORMATION: I understand that the Fury Volleyball are collecting certain personal information about my child, me and other members of my family. I also understand that this information will be used only for the purpose of administrating Fury Volleyball. I hereby consent to such collection, use and disclosure of this personal information.

I also authorize the Fury Volleyball and to take photographs of my son/daughter during their participation in the sport to display them and otherwise use these photos without charge solely for the purpose of promotional material in connection with the Fury Volleyball. These may be for print ad, display on their web site, or other promotional use as the organization may determine.

That this Agreement shall be effecting and binding upon any heirs, next of kin, executors, administrators and assigns in the event of my death.

I have read and understand this Agreement. I am aware that by signing below I Accept, I am waiving certain legal rights which I or any heirs, next of kin, executors, administrators and assigns may have against Fury Volleyball as well as their directors, officers, employees, agents, representatives, assigns and successors.
