### **HELP CONSERVE CAMP TREXLER**

Trexler Scout Reservation has been a Boy Scout camp for nearly 100 years, since General Harry Trexler deeded the pristine 755-acre woodlands to the Boy Scouts in 1927. For financial reasons, Minsi Trails Council has decided to sell the camp, which in addition to the recreational opportunities for scouts, also protects hundreds of acres of natural areas. This includes two springs that are the headwaters for Middle Creek and two small, scenic lakes, where many scouts learned to swim and fish.

Camp Trexler is one of the few remaining properties in our area large enough to provide habitat for plants and animals that need a large, unbroken forest. Forests benefit our community in several ways:

- They protect headwaters and ground water recharge areas so the wells in our yards can continue to provide clean, safe drinking water.
- They offer recreation for residents hiking, fishing and time spent enjoying and exploring nature.
- The provide a home for bear, deer, foxes, fishers, ducks, birds, fish, wildflowers and many other plants and animals.

When a large, forested property like Camp Trexler is divided into smaller pieces, sold off, and developed, the negative affect isn't just on animals. If Camp Trexler becomes residential houses, the costs related to road maintenance and the additional children in our local schools will far exceed the amount of taxes paid by new residents. We will all be paying for the development of that property. There will also be a greater chance of flooding downstream because the forest is no longer there to absorb and slow rain water. And the generations of scouts who spent summers at the camp will be left with nothing but memories.
