The writer of the letter is questioning the use of the Chief's Command vehicle. Unfortunately, the writer did not provide a name, an address or any type of way to reach out to them to address their concerns. The questions that the writer is asking were previously addressed by the Board of Fire Commissioners many years ago and are not an issue. We welcome the writer to reach out to the Board of Fire Commissioners, District 4 so that we may personally answer their questions and bring their concerns to a close.

6. Old Business

Borelli Insurance sent us a endorsement for the changes to the policy noted above. The endorsement was added to the Insurance policy binder.

The 2018 NFIRS reports have been completed and submitted to the DCA.

The City of Bridgeton's Mutual Aid Agreement were signed. There are 2 original copies. The MUA's will be scanned in and e-mailed as well as mailing an original copy to the City of Bridgeton.

The Commissioners were reminded to check and clear their mailboxes each month.

The petty cash fund in the amount of \$300.00 will be created. Mykola Myronowskyj will create the form and will purchase a petty cash lock box for the Board.

7. New Business

The approved 2019 Fire District budget was returned to the Board. It will be scanned in and uploaded to the website. The copy was passed around for all Board members to review.

The February 16, 2019 Fire District election results were reviewed and are as follows: 23 voters cast ballots at the polling location and 54 voters cast mail in ballots Budget Public question - 64 voted YES and 13 voted NO Mykola Myronowskyj and Joseph Scapellato were each both elected for another 3-year term as Fire Commissioners.

The public notice for the February 16, 2019 was reviewed and approved by the Board. This public notice will be posted ASAP and is attached to these minutes.

The membership application for Joseph Dattalo was approved by the Board. A background check did not reveal any criminal history. The application will be returned to the Chief.

During the work that Mykola Myronowskyj was doing in regard to the Pro Phoenix system it was found that an FDID number is required in order for a member to be added to the Pro Phoenix system. It was also revealed that an application for an FDID number can be issued by the DCA for a member that has not completed a Fire Fighter 1 course as long as the member is affiliated with a Fire Department (volunteer or paid). This number will be assigned to an applicant and will remain their FDID number for the duration of their career. The form will be added to the membership application and will be sent to the DCA by the Board. When the member completes the application for Fire Fighter 1, they will already have a FDID number.



7. New Business continued

The CPI adjustment for this year's LOSAP award is 2.1%. This will bring the award value to \$1,543.54 per member. 27 members achieved LOSAP for a total of \$41,675.58 sent to be sent to VALIC for LOSAP payments to the members.

Samuel Scapellato made a motion that members that may have achieved sufficient points to qualify for LOSAP during the year, AND that do not have a current LOSAP account AND have left the department will not be given the LOSAP award, Mykola Myronowskyj seconded this motion, all Board members voted Aye.

Mykola Myronowskyj will reach out to George from VALIC to schedule a meeting for members to review their individual accounts.
