Please refer to the Bylaws & Regulations of the Minnesota 50/50 Horse Sale & Futurity.

- Only horses which are registered with a breed association shall be consigned to the Minnesota 50/50 sale.
- Weanlings consigned must be registered in the members name, or that of an immediate family member and the original papers must be present for the foal to sell.
- In the event of a NSF check, the foal will be returned to the consignor. The foal may retain its eligibility in the Mn 50/50Futurity by payment from the original consignor to the MN 50/50 in the amount equaling 50% of the sale price of the foal or 50% of the average sale price of the foals consigned to the respective sale, whichever is less.
- Foals may be substituted up until the day of the sale as long as there is information provided to the Mn 50/50 for an original foal nomination deadline.
- All horses in the sale should be fit to the best of their potential. They should be healthy horses, exhibiting high body scores and have a good hair coat.
- All positions will be drawn by a committee and the horses will sell in catalog order.

1. Consignment/Catalog Fee \$75 per horse( limit 2 weanlings unless voted upon to do more per member) Payable to Minnesota 50/50.

**\*DEADLINE 8/1/16 OR BE SUBJECT TO A \$50 LATE FEE**

2. Original Registration Papers and Signed Transfer ON SALE DAY ONLY
3. Negative Coggins Test. This is to assure that the horse meets American Interstate Transportation Requirements as well as to cross state lines. All horses need to have a Negative Coggins Test within the last within the last 12 months. Please make sure that the Coggins Report is individual for each horse, multiple reports will not be accepted.
4. Health Certificate is required for all horses coming from outside the State of Minnesota, per Minnesota import requirements.

As a consignor , I am a paid member in good standing of the Minnesota 50/50 Futurity & Sale. I recognize that the organization and R & J Sale Barn are only acting to provide a time and place for the sale of my horses. By consigning my foal to this sale, I recognize that such horse will be eligible to compete in the Futurity as a two year old. I recognize that any disputes are between me, as the seller, and the purchaser, as determined by the auctioneer. Neither R & J Sale Barn nor the Minnesota 50/50 membership has any obligation, duty, or liability to me with respect to performance or non performance by any purchaser. I, as consignor of a horse or horses, agree to be bound by and abide by all the forgoing terms and conditions.
