President Thiessen called the meeting to order at 6:05 P.M.

Treasurer’s Report

Treasurer Getty welcomed the Trustees, staff, and guests to the first in person LTTO Board meeting since 2020 and to the LTTO’s new location. He provided the Trustees with an update on the health and wellbeing of the LTTO staff members & their families noting that all have remained safe and COVID free since the last board meeting. Treasurer Getty noted that there were no service disruptions to member districts during the office relocation and he thanked the Trustees for the support they provided during the office relocation.

Review the Lyons Township Treasurer’s Financial Reports

The Trustees reviewed and discussed the Lyons Township School Treasurer’s April 2022 financial statements and highlighted the amended budget on the agenda for approval. Treasurer Getty noted that the amended budget if approved will reduce overall LTTO expenditures by more than \$70,000.

Review/Approval of Review School Districts Official Records

Board of School Trustees reviewed and discussed the member district March 2022 financial records. The Board discussed the possibility of an extended delay in the collection and distribution of the second installment of Cook County property taxes and the LTTO’s ability to potentially provide financial support to member districts or other municipal entities in need of short-term cash flow assistance.

NEW BUSINESS:

FY2021 LTTO Audit Update

Betsy Allen of Miller Cooper & Co., Ltd provided the Board with an update on the LTTO FY21 audit report. Ms. Allen noted that the LTTO provided Miller Cooper with all required information in the third quarter of 2021 and that Miller Cooper has finalized the numbers, but the new GASB 84 implementation has caused the delay in releasing the audit.

Lyons Township School Treasurer’s Employee Insurance Benefit Renewal

President Thiessen made a motion to approve the FY23 Employee Benefits renewal with the condition that the Companion Life renewal rates remain at or below the amounts presented and that any increase to those rates would require further approval from the Board. FY2021 Pro-Rata Billing

Treasurer Getty presented the FY21 pro-rata billing to the Trustees. It was noted that the LTTO operating costs have decreased by more than 10% since FY16 and that revenue numbers used to calculate the pro-rata directly from member district Annual Financial Reports filed with the Illinois State Board of Education. It was also stated that Pro-Rata is billed in arrears and was calculated based on the Illinois School Code. **A Motion was made by President Thiessen** to approve the FY21 Pro-Rata billing totaling \$2,373,730.12. 



The Trustees discussed the status of pending litigation, District 204's response to LTTO's Motion to dismiss, and District 204's Motion for Rule 137 Sanctions.


4. Adjournment.

Trustee Kirksey-Miller moved to adjourn the Closed Session, seconded by Trustee Doherty. Closed session was adjourned at 8:38 pm.


