# AREA BUSINESS MEETINGS WILL, AT THE DISCRETION OF THE AREA CHAIRPERSON, FOLLOW MODIFIED ROBERT'S RULES OF ORDER, AS FOLLOWS:

#### A motion is made:

- After a second, debate is opened\*. If it does not receive a second, it dies.
- If a registered voter calls for the question, a second will be required, or debate resumes.
- The Question must be called in turn at the microphone (an individual may not speak on the motion and then call the question.)
- If the Question is seconded, a 2/3 majority will end the debate, or debate resumes.
- If the Question is not called, debate will go on until there is no one at the microphone.

#### A vote is taken to determine Urgent/Admininstrative or Tabled to the nest Assembly:

• A simple majority to vote or table

#### A motion is voted on:

- If it involves expenditure of Area funds, the finance committee will be asked to report.
- It requires a 2/3 majority to pass.
- The "non-prevailing" side will be asked if they wish to speak to their position as a minority opinion(if there is no minority opinion, the voting result will stand).
- If someone speaks for the minority, the "prevailing" side will be asked if there is a motion to revote, and it requires a second .
- A simple majority is required to revote.

#### A motion is reconsidered:

- Full debate pro and con is resumed (please limit discussion to only new considerations).
- The question may again be called and seconded, and requires a 2/3 majority to end debate.
- A sense of the meeting may be taken by simple majority to vote or table.
- If voted on, the motion must have a 2/3 majority to pass.

#### A motion is amended:

- After a second, debate is opened on the amendment only. If it does not receive a second, it dies.
- If a registered voter calls for the question, a second will be required, or debate on the amendment resumes.

Once debate has ended, the motion is voted upon. Debate on a tabled motion will be resumed under old business at the next Assembly, and the voting process will be the same as above.

\*Discussion may be entered into only by voting members. A non-voting member may offer a point of information if recognized by the Chair.

# **OLD BUSINESS**

#### ITEM 1: FULLY FUND ALL AREA OFFICERS TO ATTEND AREA ASSEMBLIES.

**Motion:** To fully fund the Alternate Delegate, Alternate Chair, and Secretary to attend Area Assemblies.

Submitted by: Michael G, District 1

**Intent/Purpose:** This is a simple proposal to allow the Alternate Delegate, Alternate Chair, and Secretary be compensated for their expenses to area assemblies. Their time and effort are comparable to the individuals that are already fully funded. Their costs to attend an assembly are the same as their counterparts, but their funding is about half as much and less than most GSR's and DCM's. It seems only reasonable to increase their funding to cover expenses for area assemblies.

**Current Practice:** The current practice is that the Alternate Delegate, Alternate Chair, and Secretary receive a stipend of \$160.00 per assembly. Whereas the Delegate and Chair are fully compensated for their rooms, meals, and fuel costs.

**Budgetary Impact:** The increased funding for the Alternate Delegate, Alternate Chair, and Secretary will be approximately \$560/officer/year, or \$1.680/ per year.

Motion Action: Amended to include all Area Officers and Tabled to next Assy.

Ron W: Would you like to read the motion?

Mark DCM D-1: Read the motion.

RonW: I would like to now ask the Finance Committee if we have the money.

David F: At this time yes we do have the monetary reserves.

Ron W: At this time the mics are open. Seeing no one at the mic, we are going to vote on the motion. (A member inquired as to a second for the motion) This is a tabled motion and does not require a second.

Taylor Alt DCM D-23: I was wondering why this only covers 5 of the 8 officers.

Ron W: I do not have an answer for that.

I may have misunderstood the statement. This covers the 4 assemblies for the year for the 3 officers. Of the officer? I was recently asked that and I would be willing to amend that motion to include all the officers. To include all officers, someone help me out here, the Delegate, Chair are fully funded and the budgetary impact for all eight officers would be \$3360.00 per year. I can rewrite the motion if that is what you would like?

Ron W: To amend the motion we need a second.

Bobby D-13: Our group voted no on this motion because it did not fund all 8 of the positions and so our district voted no on it.

Ron W: If we are going to amend this motion we need to amend it and have a second on the amendment.

Rose: 2nd

Lisa S, Area Treas: Currently serving as your Area Treasurer. I am speaking against the motion because not only do our Area Officers need to be here, We are not any more important than our Service Committee Chairs. They need to be here as well. It is not fair to the Service Com members to not be fully funded as the rest of the Area Officers. We are all equals and nobody is more important to be here.

Daniel R D-13: Home group "Keys of the Kingdom" and I am the GSR. We originally in our discussion were concerned about why we were being selective about just 3 individuals. I think that if we are going to amend we really need to send this back to the Districts and the Home Groups. Because I feel like my Home Group would like to discuss what was just said. That why are we choosing the Officers, why not the committee chairs and do we really want to go to that extent.

Reilly, Grapevine Chair, Past Delegate: I was on the ad hoc committee that originally investigated and researched the reimbursements. We took a couple 2 or 3 months to go through everything we could. All the statistics, everything. We came up to the increase to \$160 and that applies to everyone except the 2 Officers that are fully funded. Because they have to be there and they are on call pretty much 24/7. Everybody else gets the \$160. I understand that there is an ad hoc committee that is being appointed or has been appointed that is going to go through the thing that the last committee to research the amount of the stipend. I would like to see us wait for the research done by that committee. Before we leap ahead to this kind of an increase for a few people.

Jim F, Area Alt Delegate: My position is affected along with the Area Chair and as amended all the Area Officers. I can speak as it has affected me. Each assembly I go to, I go into my own pocket. Some assemblies are different some are not. I am really reluctant to speak to this. Because I am into this and I am willing to stipulate that the Alt Delegate be funded for this after my time as Alt Delegate. I talk at Prassa with all my Alt Delegates in this region. And everyone was Godsmacked that we are not fully funded. They were alarmed that Area Officers were not funded to area and only a couple Area Officers are. As far as the committees being funded, that could come in a separate motion. But this one has already gone back to the groups and discussed. Many groups, I will leave it to that. Thank you

Shannon, DCM D-15: Given that another motion we are going to be talking about the prudent reserve and spending the money that we have I say we fund all our Officers to all these things. I don't see why we shouldn't. I do like the idea what Reilly talked about and having an ad hoc committee research it. But at the same time, the positions change every year like in terms of where people live, they have to travel further, prices end up changing too. I am in support.

Dean DCM D-22: I would think we would address the committee people as separate from the Officers as Jim put it simply because we have already addressed the Officers in a motion. We are now talking 18 to 20 more people. That has got to go back to the groups. I would think, Thank you.

Ron W: I believe the amended motion was just for the officers up here.

Jeff, GSR Brothers in Arms Group, D-11: We spoke about this in a business meeting in a broader sense, I as a GSR expect my expenses be compensated when I go to an assembly to represent my group. My group feels that all officers are expected to be here representing our Oregon Area, likewise, they should be compensated. It is a general principle that if we have the money to fund you we should. If we didn't or there was extravagant abuse of those expenses that would be a different issue, but I don't think that is happening here.

Bob W, GSR 12<sup>th</sup> Street, D-31: I support the original motion that the officers get the funding. As to the committee thing, that should be taken back to the groups. That is a separate issue.

Nick F, Area Webmaster: Can a motion be sent back to the groups after it has been tabled?

Ron W: Since this motion has been amended, it can be tables and sent back to the groups.

Nick F: My comment is if you are concerned about going back to your groups, because it has been changed, per concept 3, you have all been empowered with the right of decision, even though your group may have voted one way, if you get new information here, you have the power and authority to go and change your mind. But, you then have to go back to your homegroup and explain what changed your mind. That is the great thing about Concept 3 you guys can have your minds changed but then you gotta go pay the piper.

Piper, GSR, D-1: This motion went to one and then it was revised, and that motion was taken back to our groups and we aback here to say what our groups had to say on this motion. My feeling is leave this motion as it is, this what was requested to have it revised, and so it was revised, tabled, and taken back to our groups and we are voting on that today. I think that if there wants to be another separate motion fo the committee it should be a separate motion on its own.

Jeff G, GSR, D-24: The question I have is, we recently got the budget for 2019 and it includes a line item for \$20,800 for Area Committee to attend assemblies. If the Area Committee folks not getting fully

funded, then what is that \$20000 for? Not to get into full baseball as to what that line item represents, just looking at the budget it seems like enough funds to do that. (Repeated the context above)

Dave F: Those monies include the stipends that go to all the committee members. We are talking about the fact that there are some Area Officers that are fully funded and the others just receive a stipend. The stipend is \$160 for all of the Area Committee members who are required to be here. That is what that 20K is covering.

Ron W: A reminder to keep your discussion directed to the amendment.

Theresa, Alt GSR, D-9: It was mentioned that people are going into their own pockets to get here and I don't think that is unique. I think that most of us reach into our own pockets. Coming to this assembly, I stayed on a couch on Friday night and I stayed in a fleabag hotel last night. And there have been times when I covered expenses with money from my group and my District and have used money from my own pocket to stay in maybe nicer accommodations, that was my choice. And I feel that to an extent I have been guilty of maybe not getting creative with finding in terms of brown bagging it or sharing rooms or ride sharing and I feel that when you fully fund, people don't have the incentive to do that. Try to be creative with how they get here. I feel if we spend all our money on trying to get people here then we don't necessarily have the money to do the service we need to do. I think it is a balancing act in some ways. If we get everyone here and we talk about the service that we are going to do, then there is no money to do the service. Big Books or literature or any of that stuff, then what is our purpose here.

Matt, GSR Friday Night How it Works, D-16: It is hard to make a decision without a budgetary impact on all the officers. If we can table the amended measure to take it back to our groups so that we know what we are talking about. We are talking about 20 more committee members.

Joey, GSR Turning Point Group, D-7: I response to. We come from an area that is quite depressed and we don't have the money at all. And not fully funding some of the positions that they could run for would completely exclude them from participating in this process. They can't come up with the money to for even a flea bag motel and I would hate to see their voices not get heard for that very reason. I would support and I think it is the very best idea. Not throw the baby out with the bath water. Go with the original motion. Fund the people we have agreed to fund. My group said do that and I would like to carry the message here and revisit the rest of the money in another motion as was suggested before.

Cary, D-5: Call the question

Seconded, Unknown.

Vote on ending debate: motion carried, debate is ended.

Motion was read as amended.

Vote taken on Emergent or Administrative: Divided vote by hand. Hand count conducted, 132 Emergent, 73 to table.

Vote on amended motion: Motion passed, minority opinion enacted:

Daniel, GSR Keys to the Kingdom, D-13: I realize we just took a vote on whether it was administrative or not, but I can't just vote yes on a motion that changes the budget by over \$1600 without taking back to my own group. We not too long ago had a motion that was \$1500 to send our Corrections Chair to a

conference and that was not considered ergent or administrative. We had to take that back to our home groups. I had to take that to the home group to discuss whether or not it would be ok for us to spend that \$1500. I am sorry, but I don't think it is within our concepts and traditions to increase the amount of this motion by double and not take it back to our home groups and have it approved.

David F: While I agree with the idea of funding as many people as we can, so that they are able to come here and can be inclusive and have people involved with service work that may not be able to afford to otherwise. I don't like the road we are going down by piece meal deciding who should be fully funded we just decided that all of the Area Officers should be fully funded because they are required to be here. However, there are lot of the committee members, including myself and the members of the Finance Committee who are also required to be here. We have to be here at 4:00 Friday night. And are working straight through the Assembly. You can make the argument that the Translation Chair as well and could go down the line and each one of these individuals why they need to be here and duties they need to fulfill. Hey if we had the money, I would like to fully fund every single person in this room. But I think that piece meal that we going to fund this person and this person, we are going down a slippery slope here.

Debbie, GSR Sunday Night Rouge River Group, D-7: We are opposed to this motion because it truly has an unknown budgetary impact. If you say to fully fund each Officer, there is no limit. We hope everyone is responsible for funding going to their assemblies. There is no cap. Calculated it is approx. \$300 per an assembly, but it does not state that in the motion. That being said, we have the money right now, but whos to say we always will and I support what someone else said earlier about this money can be better used in service. We are all expected, not required to be here. This can't happen without all of us being here. GSR's, DCM's, Officers, everybody. It is a service we provide to this organization for other alcoholics to the alcoholic still suffering to be here because we want to. That is my stance on it. I do not think that my group would support the increase. Well, I know that they would not. That is why we are voting no.

Patrick, GSR Aloha Men's Group, D-31: I like many people in this room am a Trusted Servant. I was given a request to take back to my group a request to fund the Alt Delegate, Alternate Chair, and Secretary as the motion was originally written. My group gave me an informed group conscious on how to vote on that original motion. Now we have an amended motion, which somehow has been deemed administrative or urgent. I myself am now a little confused as to the meaning of that now, based on the vote I just saw in this room. Personally, I would like to see this go back to my group, because you don't want to know my personal opinion. I want a group informed decision that I can bring back to this room. I did have a vote prepared for the original motion, as written. I do not have a vote, nor do I feel qualified to make a vote of this nature on the amended motion as stated. I underline stated, because I do not have a written version of this motion. The finances, ok now we got em. It wasn't that long ago, I have been coming to these rooms for a fair amount of time and it wasn't that long ago that Area 58 was coming to the Districts, and the Districts were coming to the groups saying we need to pony up \$2 per meeting, not \$1 per meeting. Right now we are back to \$1 per meeting because we are good. This needs to go back to the groups.

Motion made to revote on the amended motion. Seconded. Motion carried.

Vote to be taken on administrative or urgent.

Point of Order, we need to resume discussion on the motion prior to revoting on the administrative/urgent vote.

Eric, Past Delegate: (Asked permission from the Chair to speak to the body, approved) The motion we always called, the motion to reconsider, not the motion to revote. Perhaps you have made a change in policy from what we were doing before. A motion to reconsider, once passed has immediately resulted in further discussion. We have just heard the minority opinion only and now we allow a space for the minority and the prevailing vote to all discuss again. In order to get the informed conscious of the area.

Ron W: If you think I am not confused now, you are wrong. What I have done after the minority have given their opinion, I asked the prevailing side if they would present a motion to revote. And they did. And they seconded it.

Nick F: It does say on the back here that discussion is resumed, but that only new considerations be considered, but new discussion does happen now.

Bobby, D-13: Are we discussing whether it is urgent/administrative right now?

Ron W: Yes

Lauren, D9: My understanding that when there is a motion to reconsider then potentially to revote on the motion not whether or not to vote on the motion. So are we back to debating the motion not whether or not it is administrative/urgent.

Ron W: You are right, vote on the motion.

Kyle, GSR Tuesday Night AA, D-5: I am in favor of the motion, I am also in favor of the amended motion. The discussion I had with y group was to fully fund the Officers as they were listed in the original motion and my group felt that we would like to fund all those we could that were Officers. The amended fits my group's conscious and that is why I will continue to support the motion as amended.

Laura, GSR Happy Joyous and Free: I looked at the finance paper that was on the desk, I can't remember what it was called, anyway \$35,000 plus a year are spent on travel. Last year. That is more than most people in Sweet Home make in a year. Now, and I heard somebody speak about being in a repressed area, our county is. I think it gives us the er in us that I am going to spend some of my hard earned money to get to the assembly whether or not my group funds me or not. I want to be here, I want to be the voice of AA. I am responsible.

Carrie: I am going to PRASSA next weekend, Wooo!! And this is the deal. I am not, not going to PRASSA. Never not go to PRASSA. I fund myself to go to PRASSA. And my group also funds a GSR to go to PRASSA. The group's GSR cannot attend PRASSA next weekend. We fund up to \$250. The group can't send their GSR, because the GSR can't go. So I thought I would take notes and whatever. I'll do it and I will already be there. My service sponsor reminded me, well you have to at least request to be funded, because what if the person, I can afford it, I am going to go. But people that might not be able to afford it need the opportunity to go as well. On the years that I can't and if I am funding myself every year, my group is going to want me to go and other people like me who can afford it to go. Do want someone like me representing Alcoholics anonymous every year or would you like someone else. My point is just because I can afford it doesn't mean I should be the one to go every time. The people that can't afford it need the opportunity to of service also and we have a well rounded group.

Shauna, DCM D-15: I just want to say that I am still fully supporting our Officers to the assemblies. But given what I have heard I think we should take this back to the groups again.

Louise, GSR Tumalo: Our finance committee, our Treasurers, our trusted servants, that we have entrusted money to that have a greater understanding than any of us have of what budgetary things are going on. They have told us they have the money. Why would I go back to my group who does not have an understanding of our particular budget and how much money we have and ask them to make a budgetary decision. I just wouldn't do it. I trust them, they said we have the money.

Reilly, Past Delegate: I have something to add I didn't add to my former discussion here. In determining the amount of stipend to give the people here we are discussing. In determining that amount in not fully funding. It is based on half of what we figure would be for a trip here. That would be \$320. That we would like you to share, if you are able to. That was out of the reimbursement committee. So we didn't have any information based on sharing. So what you are discussing is not the full expectation of the \$160 to be able to fund your weekend here. Its not really what we are talking about. And Two to vote on it today when it is not urgent/administrative and with the increase in the amendment, by my calculation it is over \$3800 in increase just by doubling the \$160 and has been noted there, there has been no cap. So we are not talking just a \$4000 increase, we are talking a possible whatever you decide to spend asking for a reimbursement I would definitely like our groups to have a voice in that.

Gary, DCM D-16: It seems to me that my District would back the amended version. But at the same time as was stated, I came here with one motion to discuss. It seems that in the past we have taken monetary things back the groups again. Because it is those folks that support what is going on here. And it seems like I am being backed into that concept, right of decision. Which I am full ok with saying I voted this way to the amended version. But I can't help but feel that my groups would like to know more about this extra funding. I would vote for this. But it does leave a sour taste in my mouth.

Jim F: A couple things I would like to speak to and the first one is the sky is the limit on what people spend. We are trusted servants. We don't spend unnecessary money or at least I don't, speaking for myself and all the trusted servants I have known. An ad hoc committee has been mentioned. That ad hoc committee to my understanding has been about 7 or 8 years ago. There has been quite a bit of change since then. It was 8 years ago. Is that correct? I will speak for myself. I am not going out and spending extravagant amount of money in my position. I can tell you that I don't think anyone else there would do the same. So the budgetary impact is close to very correct.

Bre, GSR True Colors Group, D-4: I am in support of this motion. When I talked to my group about this before, we are in support of the principle behind funding these people that are here to serve us. I don't see how this is not administrative with the amendment. Just because as I heard before, my group the main thing is the principle behind it. Funding these people I heard some criticism as to it is not being fair to fund these people if we are not going to fund these people. Any progress is good. My group would support that. Also I wanted to say, the trusted servants, I know I have said this a few times, I went to the concept workshop the other night and we talked about concept 10 about giving people authority to carry out their responsibility in their position and that is coming to my mind now. I think they are trusted to use the funds to prove to carry out their responsibility and not go over it.

Greg M, D-4: It has been stated that we have the funding that would help these folks get to the next assembly. That is a sense of urgency. And you know it is not set in stone. If it comes a time when we don't have the money, we don't necessarily have to pass the basket twice, we just reduce the amount then. Revisit it.

Chaz, D-6: Call the question. Seconded

Vote on urgent/administrative: Motion tabled to the next meeting.

#### ITEM 2: AREA 58 ESTABLISHES A "PRUDENT RESERVE".

**Motion:** We move that Area 58 establishes a "prudent reserve," defined as a specific dollar amount, below which money shall not be spent, save for unexpected expenses.

Submitted by: Bob F, District 19

**Intent/Purpose:**It is suggested that AA groups have a prudent reserve set aside to meet unexpected expenses. This is usually defined as a set dollar amount. We believe the same should apply to Area 58.

**Current Practice:** Area 58 does not have a defined prudent reserve dollar amount.

**Budgetary Impact: NA** 

Motion Action: Removed by Motion Maker

# ITEM 3: ALL FUNDS THAT EXCEED THE AREA'S PRUDENT RESERVE BE SPENT OR DONATED ON AN ANNUAL BASIS.

**Motion:** We move that all funds that exceed the Area's prudent reserve (see motion 1) be spent or donated on an annual basis.

Submitted by: Bob F, District 19

**Intent/Purpose:** Cash on hand has steadily increased over the past several years. Our group donates money to the Area under the assumption that it will be used to help the alcoholic still suffering and to carry the AA message. We believe that cash balances exceeding \$20,000 violate the spirit in which the money was given. In short, spend it or give it back.

**Current Practice:** Area 58 does not have a requirement that its funds be spent or donated. Right now, thousands of dollars are sitting in bank accounts.

**Budgetary Impact: NA** 

Motion Action: Motion Failed

Bob F, D-19: I just want to say Chair, this is not considered a criticism of anybody. Our group appreciates the work of the Finance committee and the Treasurer has done. I mean this is kind of a high class problem to have. We have 35 \$40,000 in the bank. It is intended to sort of start a conversation to find out maybe there is some short term funding that we can provide to people or to EVI's. I know our EVI group is struggling right now. Or just other things that we could spend some on to carry the AA message. Rather than just have it sit in a checking account collecting 0.0% interest. Its very little.

Ron W: We will open debate, but I need to make an announcement I forgot. An eye drop Rx was dropped on the floor somewhere. If someone has found that please turn it over to D-27. It was an eyedrop prescription.

Cary, D-5: In 1955 we elected the 12 points to assure our future. That include Tradition 7. 2 years after that tradition was adopted in 1957, we chose to change the name of the Alcoholic Foundation to AA World Service Board. Because words like foundation and donation imply a charitable cause. We are not a charitable organization. If we are looking to change the words in this motion, can we please get rid of the D word. It does not belong in AA. Thank you

Renee, GSR Sunday Morning Serenity Group: I was at the last assembly. My understanding is that it costs \$33000 a year for assemblies to put on. When I look at this number of \$46,277 am I subtracting that 33,000 that we all use? That is one of my questions. Then my other question is. This prudent reserve, is that different than the operating budget?

David F: Couple of questions there. When you look at those numbers, one thing you have to keep in mind is that is a constantly rotating number. We can take a snapshot of a moment, this is what we have in the bank at that moment, 5 minutes later it changes. If you look at that number on that report, that doesn't really tell the whole story. If you look at what we have written in checks today, to pay our bills, to keep the lights on so to speak, we actually have a working number of about \$29,000 that we can spend right now after all those checks have been cashed. That will change again when the next donations come in. I would caution on getting fixated on that number at the bottom of the statement. OMG, we have \$45,000, we have to get rid of some this, because that provides us with a buffer. Yes, admittedly right now our buffer is greater than it has been at times in the past. I caution taking those numbers to heart, because things change. We all know that. It was only a few years ago that we were tickling around our threshold number, which we use instead of prudent reserve. That threshold is \$7,000 and we were right down there just a few years ago and we can certainly wind up there again. To clarify, on that threshold of \$7,000, what that indicates is when we get down to that number and below it, that doesn't mean we necessarily need to change the way we are spending our money, we do make a point of when there is an expenditure we will inform the body that we have reached our threshold or we are below our threshold. We need to keep that in mind. That is when we start encouraging people to go out to their groups and solicit the District or the area could use a little extra cash so to speak. We are in a great flush period right now and its wonderful and we can be very happy about that but it won't always be that way. Things fluctuate. Our bank account goes up and down on a daily basis as we write checks and get donations. That big number is going to change a lot over time.

Ron W: At this time, I am going to ask one of our Past Delegates to come to the mic and speak on prudent reserve and threshold.

Eric, Past Delegate: I am so impressed with the people in this room. That you have not gone running, screaming from the room and you are here because you want to be and on a topic important as this and as frequently misunderstood. The idea of a prudent reserve is frequently thought of as an amount of money that we need to keep in our bank account for a rainy fund or rainy day. There is language in our literature that talks about having the amount of your prudent reserve geared to a reserve that you will need in unusual circumstances. But, that is not the purpose of a prudent reserve. The prudent reserve is an amount of money that once you get to that place you want to distribute it to other service entities in AA. So that we will not get too much money and get distracted and get into arguments on how to spend the money or to send out the message to the groups that we don't need to make contributions anymore, because they are flush. We are not required to guard against spending the money in our accounts. We can spend our money down to one dollar. And we are not in violation of our prudent reserve. Now is there a specific question I haven't addressed that you would like me to speak to or is that helpful?

Ron W: Threshold

Eric: The threshold was already explained very well by your Finance Chair. Is there something you would like me speak to that he didn't? I think he covered it.

Nick F: The one thing I wanted to point out too, it is in the long form of the 7<sup>th</sup> Tradition and it is kind of what we are talking about here. Talks about and I will read the sentence and again, it is out of the long form. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. It goes on to say nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority." For me, we have a budget that is exactly what it says the last statement which says a stated AA purpose. We have a budget as approved as an organization for Area Officers, for our services, that we need to be able to use for this and next year. For me that is how we can get around. If we have extra money, yea but if everyone spent all their budget. We would actually go beyond our zero dollar at this very point in time. We have approved budgets, we need to hold onto that money so that we can hopefully spend it in the future. So I am not in favor of this motion.

Amy, GSR Care Group: I just wanted to say that I was one of those that misunderstood that when I would see those financial reports that says \$34,000 or \$40,000 or what ever it was that that was excess money. Since I have come to this assembly more information has become available to me. And that was a chart that was sent out to the DCM's about total income that the area takes in, total expenses of the area, and plus the deficit. Looking at that information from 2009 to 2018 that the deficit really hovers around zero. For instance last year total income \$77,799.94 and expenses of \$75,989 with a difference of \$1800. That is a big difference than \$34,000. I thought looking at those numbers, not really understanding the whole, how those sheets are written up. I thought that was a surplus that the area had. For me it was a misunderstanding. Knowing my group's conscious, I know that they would have, it would have been different had I had this information. Thank you for sending that out Lisa.

Carolyn: Call the question: 2nd. Vote passed

Vote on the motion: Motion Fails

No minority opinion.

# **NEW BUSINESS**

Chaz, Chair of the IT ad hoc committee: Interim report (see in reports under ad hoc committees)

#### MOTION #1, RESTRUCTURE WEB SITE COMMITTEE

**Motion:** Effective with the November 2019 rotation, restructure the Oregon Area Web Site Committee as follows:

- 1) Add a third committee member:
- 2) Each committee member will have a specific area of responsibility;
  - a) One will be the Webservant;
  - b) One will provide support for G Suites;
  - c) One will provide hardware and software support;
- 3) Each committee member will serve a 3-year term.

**Intent/Purpose:** The Ad Hoc IT Committee recommends that additional, dedicated support is needed to improve purchasing, set-up and maintenance of Area-owned IT equipment. In addition, supporting G Suites (email, the Google Drive utilized by Area Officers and Committees, etc.) is outside the current scope of the Area Web Site Committee. Presently, the Area has no official service responsibility covering these important needs. Having 3 committee members, each with their own specialty, is recommended to provide the IT support necessary for Oregon Area trusted servants. Renaming the committee, the process for rotation, a description of the duties and responsibilities of the 3 committee members, and a new IT Committee policy to replace the current Web Site Guidelines will be addressed in subsequent motions.

**Current Practice:** Currently the Oregon Area Web Site Committee has two committee members, the Webmaster and Assistant Webmaster. Both committee members are responsible for managing and maintaining the Area website, www.aa-oregon.org. The Assistant Webmaster serves a 2-year term then rotates to Webmaster for an additional 2-year term. Our webservants have been frequently asked to assist with hardware and software needs in addition to performing their web functions, which is not within their duties and responsibilities. As noted above, the Area has no current service responsibility covering support for hardware and non-web software.

**Budgetary Impact:** Adding a third person to this committee will incur a budgetary increase of \$640.00 per year beginning in November 2019.

(Travel to Assemblies in the amount of  $160 \times 4$  Assemblies = 40.00.)

Motion Action: Tabled to next assembly

Motion made by Chaz, 2nd Nick F

Marie, DCM D-21: I am enthusiastically supportive of this. I am an old person. I have been using computers since 1976. But things are changing so fast right now that I can't keep up with how things interrelate. Smart as I am, Savvy as I am, I am not savvy enough to keep up. I feel sorry for anyone that doesn't live in this world of computers. I think to give our fellowship a supportive presence to have help for those of us that have questions. Sometimes they are minor, sometimes they are complicated. This is a great idea and I fully support it.

Eddie, GSR No Matter What Group, D-15: Thank God. Thank God. One of the things I have noticed, as an Area we tend to struggle with technological things. I think this is a great opportunity to not struggle with this so much.

Matthew, D-20: I think this is a great idea, both motions. But I would like some input from our current Webmaster, Nick.

Nick F: I was not on this committee, but I was invited to participate in some of their meetings. I know there was a huge amount of effort, research, and time that went into these. An I am in favor of this motion.

Jordan, GSR, D-20: So I heard a lot of numbers earlier as to internet usage and smart usage connecting to alcoholics anonymous has gone on the rise. I know myself personally, know most of my generation are supposed to be good with computers. I am not, I have a lot of trouble navigating. This would allow alcoholics better access as soon as possible to find us. I think it is a wonderful thing. If it is a service that is lacking right now, we need qualified individuals who can put it in place, I think that is kind of urgent. Thank you.

Daniel, GSR Keys to the Kingdom, D-13: Call the question. 2<sup>nd</sup> Greg. Debate is ended

Vote on urgent/administrative or table. Motion is tabled.

#### MOTION #2, RENAME WEB SITE COMMITTEE

**Motion:** Effective with the November 2019 rotation, rename the Oregon Area Web Site Committee to the Oregon Area IT Committee.

**Intent/Purpose:** Renaming the Oregon Area Web Site Committee to the Oregon Area IT Committee will more accurately reflect the functions performed by the recently restructured committee. Information Technology is defined by Merriam-Webster as: the technology involving development, maintenance and use of computer systems, maintenance and networks for the process and distribution of data. The new name will better describe the purpose and functions of the newly restructured committee.

**Current Practice:** At present, there is no specific committee dedicated to serving the Area's IT needs. The committee known as the Oregon Area Web Site Committee only describes the operation and administration of the Area website.

**Budgetary Impact:** None

Motion Action: Tabled to next assembly

Motion made by Chaz, 2<sup>nd</sup> Gabriel, DCM D-11

Question called Bobby, 2<sup>nd</sup> Nick F Debate ended

No Vote on Urgent/administrative, motion was tabled by the Chair.

Ron W: We are looking at the time to see if have time for another motion. Is Kelly in the room? Are we allowed to go over 1200? By how long? (answer 1 hour) OK. So I will take a sense of the body over whether we stay past noon. (The vote indicated the body did not want to stay past noon.)

#### MOTION #3, PURCHASE SOUND EQUIPMENT

#### Motion:

Area to purchase sound equipment for use by Oregon Area when needed. Purchase to include recommended amplification and recording equipment as identified in the Sound System Ad Hoc Committee Final Report, submitted February 2019.

# Intent/Purpose:

The Sound System Ad Hoc Committee researched both the current sound needs for Oregon Area, as well as the current practice of many Areas across the country, and have found that owning our own equipment would be an affordable and productive option to meet the needs of the Area moving forward. If this motion passes, the committee has two members who are willing to assist with both the equipment purchase and putting it into use at a few assemblies. Once the equipment has been used over a few assemblies, informed recommendations can be made regarding who should manage and operate the equipment moving forward. This might include:

- Host committees
- An existing area service committee (e.g. the website committee)
- A possible new area service committee

This motion is only focused on the equipment purchase. The idea is to continue to negotiate sound equipment terms into facility contracts, but by owning our own equipment we would have a cost-effective option to meet our sound needs for those occasions where the equipment is not included with the facility contract, or is not affordable. The package we are recommending will include a separate recording device for recording the business meeting even when we are using facility-based amplification equipment. A recommendation will come later as to who will operate the equipment. Full details of our recommendations can be found in our Final Report.

#### **Current Practice:**

The Area **had** been cooperating with a third-party vendor, with affordable terms for the Area, and that vendor is no longer available.

The committee also identified the Area's basic sound needs, which include:

- 1. Have sound amplification available at assemblies that includes three microphones, a PA, speakers and associated cables etc.
- 2. Create a basic recording of the business meeting.

#### **Budgetary Impact:**

\$2,300 to the 2019 Area Budget. A one-time purchase cost not to exceed \$2,300 to purchase the identified Fender package in the Sound System Ad Hoc Committee Final Report. The estimated cost of the Fender equipment is just under \$2,000. We are adding \$300 to the request to accommodate any unexpected costs.

Motion Action: Motion Passed

SJ, Chair Sound Equipment ad hoc Committee: We are submitting our final report today. You should have two final reports in front of you. One is a full final report and the other is an Executive Summary of the report, which is just a page. The remainder of the report can be found in the Reports Section.

Motion by SJ, 2<sup>nd</sup> Shauna, DCM D-15.

Point of Information: You said something was not available anymore?

SJ: We have used one or 2 vendors consistently in the past, but neither of those vendors are available any more for us. So we are having to come up with a different solution available to us.

Randy W, Area Secretary: I am absolutely in favor of this motion. This is how we do our minutes for this meeting. And to accurately get the minutes recorded on paper, we have to have a good sound system. This time I have worked with Chase and SJ in getting a sound system that seems to be working very well. As a matter of fact, the reason the minutes were so late the last assembly, we did not get the audio until over a month later. This way, I will have the audio when I leave here today. We can get the minutes out, we can get the motions out to you guys so that you can see them. Also it provides an excellent archive material from audio.

Peter, DCM D-12: I am full in support of this motion. I think it doesn't even have to go back to the groups. One thing I wanted to say as a point of clarification. I looked over the full report. It is really a riveting read, everyone should look at it. There is one thing about it, I talked to SJ about it. Under App 2 where they looked at the different systems, they do end up recommending the Fender, it is referred to as the Fender System. If you look at just the headings for that it show the Passport Venue which is the same as the Fender System.

Reilly, Grapevine Chair: I think this is a well researched and affordable solution to something that has been a problem and I appreciate and commend the committees work on this. And thank you for the one-time expense instead of a reoccurring budget item. I really am grateful for that. I only have one question and that is where will it live?

SJ: We talked about that a little bit, there are a few different options. One is the host committee, it could pass from host committee to host committee like other host committee items do. If that doesn't work then we may have to find other options. That would be the most likely option. Looks like Randy might be able store it too.

Ariel P, GSR Davis Road Group: I have a question, what are the regular fees that we were charged for someone to come out and do the sound? How much less is it to pay for storage?

Ron W: As far as I know, we don't have anyone else to come out and do our sound system.

Ariel P, GSR Davis Road Group: Before, what were we paying. What is the decrease in paying for only having to do a one time fee? We didn't get a 15 page report at our table.

SJ: I have some extra copies in the back and it is also available on line, I forgot to mention that. Nick, under very short notice was able to put the reports on line. Thank you very much. I guess I not quite clear on the question. If you are wondering what we paid the vendor before, we had a standing agreement of food and lodging that would be paid to them. Whatever the hotel cost them. Wherever we were and the meal costs as well. And I think there was some additional payment made. Originally as a purchase of CD's to fund the cost of recording. That part of what we used to pay the vendor. As part of a standing service committee or host committee it would sort of be built in to the cost.

David F: Just to expand a little on what SJ said. It would vary from assembly to assembly. One thing to point out, we were providing a hotel room that would be a single occupancy. We are paying for a person to stay in a room for 2 nights. Travel expenses, whatever else like that. Somewhere in the range of \$400 to \$500 per assembly. One thing to keep in mind, this would be a one time cost. Even if somewhere down the line we needed to establish a committee position in order to handle that to be at

all the assemblies to operate that would be a per assembly cost of \$160. Just like funding any other committee member to an assembly. If you look at it that way, a savings of \$240 to \$340 per assembly. We would pay off the one time cost in less that 2 years.

Marie, D-21: Just a quick question about whether this would include support for the hearing impaired? Would we use our current equipment for that? Or would different kind of equipment be required and will it work with the system we get?

SJ: We did check the Fender system to see if it had outputs for the FM system and it does. It should play well with our system for the hard of hearing.

Kim, GSR Straight Talk, D-15: My question is the warranty and what are the anticipated maintenance costs of owning our own system?

Chase B, Past Delegate: I was walking up here, I'm about to make some shit up. Gus used to say, its after 10:00, I am going to make some shit up. The warranty would be per the manufacturer and if there is any additional warranty from where we purchase it from. That would be provided. WE did not drill down into that and I apologize. What was the other piece, it was a 2 part question? Maintenance, we looked at that looked at it and if was a soft cost of 3 or 4 hundred dollars for the host assembly that they were shouldering for the last couple years that would be about \$1600 a year that we have been spending whether out of the Area treasury or other AA funds. Figure that a \$2000 purchase one time and it lasted us five years then we had to replace it there would be net gain of \$3000. We did not take that deep of a dive. My own experience of Area owned stuff projectors, info machines, other stuff. I am in support of this motion. Stuff ends up in somebody's garage sometimes after rotation 5 10 years after it being purchased, we don't know where the hell it went. And we find out later that it is there and we have already purchased replacement equipment. So Tradition 9 will always be alive and well. We will only be as organized as we have to be. There is a chance that we will buy this and use the hell out of it for 10 years and it will disappear and God will bring it back sometime. I don't know. So maintenance and warranty in AA are dubious things. I hope I answered your question, I know I didn't.

Kaly, D-23: I just had a question on who is going ot be in charge of this? Is it going to be IT web committee of the host committee going to have to deal with it?

SJ: It will be the Host committee that will carry on with the rest of the stuff.

Ed, GSR Men's Early, D-22: Call the question. 2<sup>nd</sup> Greg, Debate ended

Vote on urgent/administrative or table. Vote to vote on motion now.

Motion vote: Pass

Minority opinion:

Daniel, GSR Keys to the Kingdom, D-13: I am sorry, \$2300 we are spending money it needs to go back to our home groups. Can't help it.

Dean, DCM D-22: This is urgent, we don't have a sound system. (interrupted by Ron to speak to the minority opinion only) I take it all back.

Ron W: Is there a motion from the prevailing side to reconsider? I guess we are going to hear more debate. You know we ae going to run past noon. Oh, we need to vote to reconsider.

Reconsider vote failed. Motion stands as passed.

Direction was given to throw away any copies of motions that were not brought before the body and please disregard. They are not to be taken back to the home groups.

Lisa, Area Treasurer: Final report, Came into Assy with \$56545.83. Wrote checks for \$13356.57. Ending balance of \$43189.26 minus PRASSA \$13900.06 final ending of \$29289.20.

Motion to adjourn, Penny H, Area Alt Chair. 2<sup>nd</sup> Lisa S, Area Treasurer. Motion carried.

As I mentioned earlier this is a busy time in A.A.! Attendance at PRAASA will afford your trusted servants another opportunity to become more informed on Conference Agenda items and issues of concern to A.A. members. I look forward to seeing you there.

#### **AAWS** report highlights

- 4 major projects concerning Communications are in focus. Website design, A.A.W.S. App, You Tube and ERP software. The App is now moved ahead in priority over the website rather than happening together and will be launched in the spring. You Tube has 2 videos for professionals now and the views have skyrocketed in the last couple of months. The first month of YouTube there were over 2000 views. You Tube is being recommended through the "What's App" especially by Spanish speaking people.
- GSO is working to implement ERP, a new software. This project has slowed due to data
  migration and is continuing to be a priority. This will delay the original launch date, and a revised
  date will be announced soon. There were so many databases, separately made and supported
  over the last two decades, that this process has been a bit more challenging than originally
  estimated. It is important to note that FNV "Fellowship New Vision" will be replaced by this new
  system.
- Seven candidates were interviewed for the two Class A openings (replacing David Morris and Ivan Lemelle). The Trustee Nominating Committee recommended Sister Judith Karam from Sisters of Charity. She knew Sister Ignacia and has a very extensive background in alcoholism and hospital administration. The second is Dr. Al Mooney. He has spent many years dedicated to helping alcoholics as a doctor and brings a wide range of experience to the Board.
- The new Public Service Announcement "Changes" is now posted to the aa.org website.

- The Twelve Concepts audio project is moving along well, with English and French recordings approved and Spanish corrections in progress. The Daily Reflections video project has been suspended.
- A summary of financial results for 2018 included: Contributions were \$8,384,721, 2.25% higher than budget and 0.29% lower than 2017. Online contributions were \$878,333, or 10.57% of total contributions. Sale of literature was \$14,020,149, and gross profit after shipping of \$9,452,615, or 67.4%. This profit is then used to support the publishing operation, and to fill the gap between expenses and contributions for services. Operating expenses were up 8.56% over 2017. This was due to salaries (new employees), litigation, ERP Software costs and implementation, and travel due to conference being in NY vs. Rye and World Service Meeting being in South Africa.
- Our Great Responsibility: A selection of Bill W.'s General Service Conference Talks, 1951-1971 is on track for mid-April and will be priced at \$10.00 in all 3 languages.

#### **AA Grapevine report highlights**

- GV net income is -\$164,260. This loss is primarily due to publisher change. La Vina service is at
  a shortfall of \$148,467. There are also a couple of new positions that were filled. 1 is an
  Outreach Person and 1 is an assistant at La Vina. Part of the increase for La Vina is the color
  magazines that were produced in 2018. The La Vina magazine in color has been extremely well
  received.
- Suggested Grapevine book topics for 2020 and beyond were forwarded to conference committee.
- Removing the Alcoholism at Large page from Grapevine was forwarded to conference committee

- On aa.org, what's new, you can read the press release about our visit to Cuba and a Class A Trustees interview on radio and TV. Cuba recognizing A.A. is a big step toward carrying the message.

#### International Conventions/Regional Forums

- Regional Forums is looking into making power point presentations in French or Spanish for regions where there is a large attendance of French or Spanish speaking members
- A virtual Forum continues to be worked on
- At the 4 Regional Forums in 2019 this committee will purchase 50 Grapevine Completes for each to give away to 50 first time attendees at a cost of just under \$10,000.
- The International Convention in Detroit is budgeted for 47,500 attendees with a registration fee of \$115 for early registration and \$140 for registrations after 4/15/20.

- Several progress reports on new pamphlets and revisions will be forwarded to conference committee
- A couple of items that were forwarded were a 5<sup>th</sup> Edition of the Big Book and the development of a Literature Workbook
- One item that was not forwarded was a Plain Language Big Book, however we asked the Board Chair to appoint a subcommittee to include members of Accessibilities committee to look at this further

#### **Treasurer February 2019**

Good morning Oregon Area, my name is Lisa, and I am an alcoholic. My sobriety date is January 31, 2012 and my home group is the Shine at Nine Group in District 11.

This past quarter has flown by. In December, from writing draw checks as our new fiscal year started, responding to several emails, as well as making sure we are prepared for this next fiscal year with our CPA and insurance agency. In January, I attended our Area Orientation, where I assisted David, our Finance chair, in training our Area Committees and DCMs about their different financial needs for their positions. The finance committee and I worked very hard to ensure last year's financial statement numbers matched and the books audited so that we could go over the year-end financial statement, which we will go over today. I celebrated my 7<sup>th</sup> sobriety birthday on Thursday, January 31<sup>st</sup>, and took my coin, while visiting in the state of Kansas. When I returned, it looked like I brought winter back with me as Portland experienced its Snow-mageddon, the night I arrived.

Enough about me - Are you guys ready to talk about the money?

First, I have been hearing from our fellowship at the past several assemblies as well as via email, concerns regarding the spirit of corporate poverty and the Seventh Tradition. Two weeks ago, I emailed a document to all DCMs, Alt DCMS, Past Delegates and Area Committee. This document is a summary of our Income and Expenses for each Fiscal Year End for the past 10 years. I have requested that the DCMs distribute this information accordingly. If you have not received this and would like a copy, please come see me during the break or after the meeting. You can also email me at <a href="mailto:treasurer@aa-oregon.org">treasurer@aa-oregon.org</a>, and I will email it to you as well.

Now onto the Financial Statements – let's have some fun!

You have 2 different Financial Statements on your tables this morning, the FYE 2018 and the 2019 Q1 Financial Statement. Please find the one that says Oregon Area Financial Statement FYE at the top. This is the first report we will look at. By the way, FYE stands for Fiscal Year End.

Our fiscal year begins December 1st and ends November 30th. Therefore, this report includes all income and expenditures from December 1, 2017 thru November 30, 2018. So beginning at the upper right is the amount of money we started FY 2018 with, it's called our "Cash in Bank" it was \$33,380.75.

To the left is the income section and the last line in that section shows we had a Grand Total Income in 2018 of \$94,385.00. \*\*Just a quick reminder that the income includes the 2022 PRAASA funds that are being held in trust\*\* When we add this to our Cash in Bank it gives us Total Funds for 2018 of \$127,765.75.

The next section down is our expenditures. Going left to right, the first column shows the 2018 budget, the next column shows the amount spent from each budget line, and the year-end budget balance is shown in the next column. The next column to the right shows any return of funds made by your Area Service Committees and the last column shows the Total Year End Expense for each budget line - which shows where your seventh tradition dollars were put to work last year.

At the bottom of this column you will find the total of \$75,889.03. If we subtract this amount from the total funds for 2018 of \$127,765.75, we get the Cash in Bank on 11/30/18 of \$51,876.72 shown in the box at the bottom right of this report. Remember those 2022 PRAASA funds? That amount is \$13,900.06 – which leaves us an actual available cash of \$37,976.66.

Are there any questions regarding the 2017 FYE?

The second financial report is our 2019 Quarter 1 statement – please find those on your tables.

This report is in pretty much the same format as the Fiscal Year End statement but it runs only from December 1<sup>st</sup>, 2018 to February 21, 2019, which is the day before this assembly. Again, let's start in the upper right side; we started the 2019 Fiscal Year with a Cash in Bank of \$51,876.72.

To the left is the 1st quarter income totaling \$18,696.40 which Crystal went over in detail in her report. If we add this to the Cash in Bank it gives us Total Funds of \$70,573.12. The next section below is our expenditures; the first column is our 2019 budget, the column to the right labeled Q1 is our first quarter expense. These expenses consist of draws taken from Committees and Officers, Archives Rent, Area PO Box and our Area Orientation held in January. These expenses for the 1st quarter of 2019 totaled \$14,027.29. This gives us a Q1 Ending Balance coming into this Assembly of \$56,545.83 shown in the last box on the right hand side labeled Cash in Bank as of 2/21/19. Again, we have the PRAASA funds held in trust of \$13,900.06, which leaves Available funds in the amount of \$42.645.77.

The very last section shows Outstanding Assembly Advances totaling \$3,000.00. These advances are advanced to Assembly Host committees as seed money

Please take notice that there are 2 changes to the approved 2019 Fiscal Year budget. The first change is that there have been funds added to the Ad-Hoc to Assemblies budget. Our Oregon Area Guidelines give the Chair authorization to give any Ad-Hoc Committee chairs that attend assembly the same stipend that Area Officers and Committee Chairs receive, unless they are not funded by any other method. At the time that the budget was approved, we did not have any Ad-Hoc Committees appointed.

Since then we have had 4 committees appointed by our Area Chair; 3 of those Committee Chairs are here this weekend.

The second change is in the Administrative Area of the budget. You will see the addition of the Budget Line – State Business Filing Fees. These fees are an annual expense of doing business in the State of Oregon. Because of changes in banking regulations, we are required legally to have our business entity registered with the State of Oregon. Since both of these items are administrative as well as within the guidelines, these were added to the budget.

Are there any questions regarding the Q1 2019 report?

Finally, most of you know that your past Area Treasurer, John and I worked tirelessly last year to make sure our Business name and FEIN at the IRS, Oregon Secretary of State and US Bank all matched, and that our legal business name is Oregon Area General Service Committee. There was an administrative decision made to file an Assumed Business Name registration to utilize the name Oregon Area 58. This decision was made due to our website, GSO and a lot of the search engines using this name. Therefore, it was important that we registered that name as well. Therefore, you can now use either business name to refer to Oregon Area business.

We always want our Area Treasury to be transparent, and we will keep you informed of our checkbook balance during the assembly. If you have any questions, please email or call me, my information is in the Area Roster and you can also find my email on the Area website under Finance, Treasurer.

# SERVICE COMMITTEE REPORTS

#### **Access Chair February 2019**

Warm Greetings, Oregon Area 58! My name is Sarah, and I am an alcoholic. My sobriety date is July 29, 1991. This is my first report as your Access Chair, and I am excited and honored to be serving you in this new position. I have really appreciated the warm welcome and encouragement so many of you have extended to me in the past few months as I learn to navigate how I can be of service in the broad range of issues that prevent access to participation in our program of recovery in Alcoholics Anonymous.

One of my first tasks was to inventory everything in the numerous boxes passed on to me from Perry, our previous Access Chair. I just want to remind everyone that the Access Committee has a package of hearing assistance equipment (including a transmitter, 9 radios and earphones) that you can borrow for your events. FM radios with earphones are also available for tuning into the sound system at our assemblies.

I attended the Oregon Area Orientation in January and many thanks to all the Area Committee members for excellent presentations on topics that helped me dive deeper into the details and resources for service in our Area.

Also in January, I received an information request from the General Service Office for our shared experience with cooperation with the Armed Services. A subcommittee of the Trustees' Committee on

Cooperation with the Professional Community/Treatment and Accessibilities is looking at ways to carry the AA message to active duty, reserve and retired military personnel. They would like to hear about any activities in Oregon Area 58 that involve National Guard or Reserves units, military hospitals, armories, VFW Posts, United Service Organizations (USO), military installations, connecting to military members who are deployed, and efforts to help AA members on active duty transition to a sober civilian life. I sent out this request to the Oregon Area Committee, DCMs and alternate DCMs and have received a couple of responses so far. If you have experience to share, please come see me during the assembly, or send me your information by e-mail to <a href="mailto:access@aa-oregon.org">access@aa-oregon.org</a> by no later than **February 25** so I can summarize and pass it on to GSO by their deadline.

Many thanks to Nick, our incredibly speedy and talented Web Servant, for helping me revise the Access Committee page on the Oregon Area web site. I was so impressed with how quickly and accurately he translated my edits. Some of the new additions include a link to a video of a District 9 panel on "Inclusivity in AA" that is interpreted in American Sign Language, updated information on the Portland Deaf Access Committee (PDAC), and resources on safety and inclusiveness issues that can seriously affect access to our program and meetings. The next addition will be a contact form for gathering interest in Access service opportunities.

I am looking forward to getting out to visit your Districts, and was excited to receive my first invitation from Rose, District 4 DCM, to talk about Access at their meeting in Salem in March.

Thank you for this exciting opportunity to be of service, and I am looking forward to working with all of you on Oregon Area access issues and concerns.

Our Hispanic members have always been very involved, and their enthusiasm impressed me. I wanted to be a better communicator, so a few years ago it was time to finally learn Spanish. The district is already planning to hold a general sharing session on April 7th to discuss and gather feedback from the groups about the 2019 General Service Conference agenda items.


In January The Alternate DCM, Bonnie and myself made the journey to Eugene for the Area Orientation. Lots of valuable information on connecting our District to the Area was presented. I was also able to hear the experience, strength and hope of fellow DCM's and Area service officers and chairs. Service is alive and flowing throughout our state! There are so many ways to be of service to the fellowship and the still suffering alcoholic no matter what your schedule may be. Are you available? The district held its 6th Area Assembly Orientation for all those interested in what happens at an Area Assembly geared specifically to new GSRs. We covered all things to do to prepare for the assembly, covered each agenda item in detail and answered many questions. There were five members in attendance and three of them were new GSR's!!! If you are interested in this orientation and would like to learn more about what we do please feel free to contact me. (dcm@district5aa.org)

The District's guidelines have been updated to reflect our current practice. They are now available on the D5 website. www.district5aa.org

At the December District meeting we voted on the 2019 budget and it was approved unanimously. I would like to thank all the groups of District 5 for their continued support so that we can continue to carry the message outside the rooms of A.A.

Here is what our dedicated Committee Chairs have been up to:

Archives continues to dive into the monumental task of bringing the D5 archives up to GSO standards. Valorie has been actively interviewing long-timers to get their stories documented, documenting group histories, and organizing and preserving the history of District 5. Sadly a long timer in the LaPine area has passed before his story could be recorded. A lot of the LaPine area history of AA unfortunately went with him. This just emphasizes how important it is to do everything we can to get these stories recorded before they are lost forever. Two members have made themselves available to serve on the Archives Steering Committee. The committee will work to develop archives policies and will provide a group conscious for developing motions to bring forward to the district with regard to archives activities. Corrections: The Committee held 184 out of a possible 192 meetings for 96% coverage in 2018. Five people took advantage of the Ride to Recovery Program. There are currently 37 active members with 14 backups for a total of 51 members to keep the meetings going in the jails of the district. Five new members have been recently approved by the Sherriff bringing the total number of members able to bring meetings into the jails to 56. The groups have been very generous and have provided plenty of literature to be used to carry the message within the correctional facilities in D5.



**CTF:** The Primary Purpose of District 5's Cooperation with Treatment Facilities (CTF) Committee is to carry the AA message to the alcoholic who still suffers. Experience with alcohol is <u>the</u> one thing all AA members have in common; sharing our members experience in the AA Program of Recovery with those yet to reach, or find their way back to Alcoholics Anonymous focuses this Committee's efforts. Your Cooperation with Treatment Facilities Committee is simply a conduit to help connect you, your Group, and/ or your Committee to alcoholics, particularly those receiving treatment for alcoholism, though not established in AA.

As a basic "tool" for pursuing its Primary Purpose, CTF facilitates Speaker Panels, where 3-4 sober AA members share their experience with our Program of Recovery for ~10-15 minutes each. Personal

experience receiving medical and/or therapeutic treatment for alcoholism is not the focus of CTF Speaker Panels, nor is it a qualification to join a CTF panel. AA experience and literature suggests that "solid sobriety [i.e., experience practicing AA's 12 Steps], a knowledge of the Traditions and absolute dependability are qualifications needed to serve."

D5 CTF began 2019 with far fewer active panels than it began 2018. A year ago we were coordinating between 54-73 AAs on approximately 18 panels per month at 14 total sites in cooperation with 4 treatment providers. Throughout 2018 nearly all panels and sponsored meetings at inpatient and intensive outpatient facilities were placed on hold or considerably reduced. Of the facilities that slowed or suspended D5 CTF panels in 2018, "too much opining, advice, and drunkalog and too little actual experience with AA's Program of Recovery," "anemic response times," and "a focus on correctness or indifference with those who don't immediately identify as alcoholics or yet understand what alcoholism is" have been common feedback. With this feedback in mind, the D5 CTF Committee has spent much of the last few months refocusing to better pursue its Primary Purpose, and better cooperate with various local treatment providers.

To that end, CTF began a weekly Saturday afternoon panel at St. Charles Hospital in Bend. Attendance by hospital patients has been spotty thus far, though, simply by being there, CTF has been able to present the AA Program of Recovery as an option for healthcare professionals actively treating, and often frustrated by, alcoholics "in their cups"; we have had several opportunity to make numerous 12-Step calls, carrying the AA message to patients not able to physically attend the weekly panel; and, open lines of communication regarding other potential sites for CTF to cooperate with largest healthcare provider in District 5. This panel is open to anyone who wishes to attend and appears on the current Intergroup Meeting Schedule as "CTF Saturday Speakers".

D5 CTF also recently added two (2) weekly Speaker Panels at detox facilities Redmond. These new panels are held every Tuesday, from 7-8pm, at two (2) separate detox facilities -- one mental health, the other residential alcohol and drug treatment. This year alone, these three (3) commitments will require coordinating ~150 panels and over 600, 10-15 minute slots for sober AA members to share their experience, strength, and hope with alcoholics who've not yet reached Alcoholics Anonymous. There are currently only five (5) AA members with firm, structured commitments to facilitate these panels in 2019.

Outside weekly panels, CTF cooperates with various other treatment facilities, coordinating Speaker Panels once every four (4) to ten plus (10+) weeks depending on the facility's needs. D5 CTF also hopes to establish cooperative relations, including panels, with the numerous sober living houses, assisted living facilities, mental health facilities, Veterans Organizations, homeless shelters, and other hospitals throughout District 5. There are currently only a handful of D5 AAs with standing commitments to help verify and update all existing CTF contact information, as well as focus future direction.

To get involved: join CTF at an upcoming meeting/info session! We'll next gather Wednesday, February 27, at 5:15pm in the Hutchinson room at the Deschutes County Library in downtown Bend. We'll also get together at the same time and location on Monday, March 25. We ask any and all D5 AAs -- be they individuals, GSRs, and/or other Intergroup or D5 Committee Chairs and Officers -- to join us and help carry the AA message beyond the relative comfort of our respective meetings, groups, and service structures.

Please let us know what we can do help connect you, your group, and/ or service committee with those yet to reach, or find their way back to Alcoholics Anonymous.

**CPC:** The committee has been actively pursuing AA members to help distribute information to the professionals within the district. The addition of the hospital meeting in D5 has opened some doors to the medical community. The main focus of the CPC committee currently is health care professionals. The CPC mailings are being put together and sent out to cover the outlying communities as best they can. CPC, PI, and Treatment are all working hard in a collaborative effort to educate and cover the district with literature for anyone with an interest.

**Grapevine:** The committee has been out spreading the word about the Grapevine and bringing the display and its his wares to speaker meetings, potlucks, group business meetings and has been actively reaching out to Grapevine Reps throughout the district to help them better understand what the Grapevine has to offer. The committee is currently putting together a set of talking points that can be given to groups Grapevine reps in order to help them further educate the fellowship about the Grapevine.

**Public Information:** The committee has been actively growing and is now comprised of 6 members plus the committee chair Donn.

All the members of the committee are included in the regular distribution of A.A. literature and meeting schedules each month and the continued search for new places to carry the A.A. message via Public Information. Some of these locations include City Halls, emergency rooms, psychiatric wards, and doctors' offices. With 2019 kicking off and a new committee member an outreach program to retirement communities and senior living centers is in full swing.

The New Year's holiday included PI's making a trip to our local Indian reservation (Confederated Tribes of Warm Springs) where to bring the AA message in print, making big books and AA pamphlets available at the New Year's Eve Sobriety Powwow.

The hard work of reaching out to the schools is starting to have results and has resulted in the need for a very important event - a Speaking at Non-AA Meetings workshop - has just been confirmed for next month. PI and CPC are very excited about this as it has been a long time in the making. Upon completion we will conduct our very first District 5 school panel presentation in a county school with attendees from the workshop.

**Website:** With all the activity in D5 the web chair has been actively posting new flyers and events as well as adding content and making the site friendlier to use.

Unity is a topic that has been in my thoughts, prayers and heart in recent days. As we approach the holidays I'm finding it even more important to keep unity as a forethought to the words I speak and the actions I take. Tradition One reads "Our Common welfare should come first; personal recovery depends on A.A. unity." I need to remember that A.A. does not need me but I sure need it. I need to promote unity by acting, speaking and thinking in unifying ways. I need to carry unity in my heart whether inside or outside the rooms of A.A.

This is my first report to Area 58 — I rotated in as DCM for District 21 on January 1. I'm excited to be here and I feel extremely blessed to be the one to tell you a bit about what's going on in AA in Linn and Benton Counties.

At our November assembly, a conversation over lunch led some of us to launch a fundraising effort for our AA brothers and sisters who lost so much in the Camp Fire in Paradise Valley last fall. After consultation with our delegate, Vera, we decided that the most appropriate action to take to support their recovery would be to replace the AA literature they lost in the fire. We passed around donation cans at our meetings, and on January 24 we wrote a check for \$776.91 to the North Valley Intergroup in Chico to use for this purpose. Our hearts are with our members and their families and friends as they work toward rebuilding their lives after that life-changing tragedy.

We had invited Reilly K. to facilitate a Grapevine Funshop in Corvallis on February 10, and our members were really looking forward to it, but as we looked at the weather report a few days beforehand, we began to realize that we may be asking Reilly to drive on a sheet of ice to get to us. As a testament to the commitment that enables her to maintain such long-term sobriety, she was willing to go to any lengths! We decided, however, that her safety was more important, so we postponed the event and will be setting a new date for it.

I'm happy to report that the PI roundtable at the last assembly lit a fuse under our new Public Information Chair, Jessica C.! She pulled together a committee of 10 members to support a new effort to carry the message into middle schools and high schools in the district. Next week they'll be presenting to a total of about 400 students in 16 health classes at Corvallis High School. They've launched a fundraising effort to provide literature for the schools, and with little effort so far have raised \$73. I can't think of a more worthwhile way for alcoholics to spend their time and money than supporting our young people in this way.

At our steering committee's request, I formed an ad hoc committee to review our district guidelines, which were last updated in January 2013. So far, we've met to identify the concerns and develop a strategy for how to approach a revision. We're asking for input from our current and former officers and service committee chairs to help us align the guidelines with our collective mission and vision, and the on-the-ground reality of what's happening today. We're also reformatting and reorganizing the flow of information, which seems to have been compromised by multiple revisions since 2004.

I drove to Salem last Thursday night and sat in on the District 4 meeting. It's the first time I've been to a district meeting outside my own district, and it was great to see the differences and similarities in how we conduct our meetings. Afterwards, I attended the second meeting of a small leadership group that Rose D., District 4's DCM and my new service sponsor, formed and invited me to join. It was an enriching and inspirational experience, and I'm so grateful to be a part of the group. The most useful idea that came out of it was Erik K.'s idea to "Listen as though you don't have an opinion." I see that as a worthy goal as I find my footing in my role as DCM.

Upcoming events include a District 21 fundraiser in conjunction with our regular Saturday Night Survivors Speaker Meeting in Corvallis.
