Opening

- The regular monthly meeting of the Liberty Township trustees and a Public Hearing was held on Monday, December 12, 2022 in the shop behind the township hall building. Bill Seigel, township trustee chairperson, called the meeting to order at 6:30 p.m. He led the Pledge of Allegiance and stated that the meeting is being recorded.
- Roll call was taken with the following answering as present: Bill Siegel, Bill Bogantz and Doug Strait.
- Bill Siegel stated that the minutes for the Regular Meeting on November 14, 2022 are available in the back of the room.
- Doug Strait made a motion to approve the minutes from the November 14th, 2022,
 Regular Trustee meeting. Bill Bogantz seconded the motion. The motion passed with all YES votes.

Public Hearing

Zoning

- The trustees discussed the proposed zoning resolution changes.
- Doug Strait made a motion to approve the updates as presented to the trustees for Article 2, Section 200; Article 9, Section 916; and Article 11, Section 1104 item #7. Bill Siegel seconded the motion. The vote: Bill Siegel, NO; Bill Bogantz, YES; Doug Strait, YES. Motion passed.
- There were no permits issued in November.

- Roads: The snow plow is ready.

Melodie has the deeds ready for signatures. Bill Siegel contacted the mowers about mowing and trimming of the cemeteries.

- Melodie presented the funds available for appropriations and her proposed 2023 temporary appropriations. The trustees discussed the amounts.
- Bill Bogantz made a motion to approved the proposed 2023 Temporary Appropriations. Doug Strait seconded the motion. The motion passed with all YES votes.
- Bill presented to the trustees a cabinet for security equipment that he would like to purchase for about \$500 using the More Grant. The trustees agreed to the purchase.
