

3. During the month the Police agency handled a sex abuse case which entailed asking the NYSP for assistance in handling of sensitive issue with the crime. Cohocton PD along with NYSP special unit out of Canandaigua interviewed the victim in a controlled setting, investigation is ongoing with charges pending.

4. Ticket numbers are starting to increase with more individuals being back on the road, during the month of June and July the Cohocton PD will be working DWI details along with special traffic details with the Steuben CO Sheriff's Department. During the traffic detail the SCSO & CPD will be having a road check at different places around the township. The monthly meeting of the Cohocton Joint Planning Board was held on Thursday evening, June 4<sup>th</sup> 2020 at 7:00 pm in the Town Office located at 19 Main St. Atlanta NY. This was the first meeting since March due to the COVID-19 virus.

Present were: Chairman Russell Gray, Jeremy Wise, Ted Walker and Marty Oehlbeck.

Absent: Freda Feely and David Pietrucha.

Also present: Jane Towner, Ron Towner and William Sick (Cohocton Valley Mills).

The meeting opened at 7:00 pm with Chairman Gray leading in the Pledge to the Flag.

The minutes were read and a motion was made by Ted Walker to approve the minutes as presented, seconded by Jeremy Wise. Motion carried.

First on the agenda was the resignation letter from Judy Carey. I have decided to retire from the Planning Board Clerk/Secretary position after 6 ½ years. A replacement has yet to be decided at this point.

Discussed next was the Cohocton Valley Mills (Grain Storage) which will be operating from 3 Wilcox St. in Cohocton. Bill Sick and Conway Slayton will be running the facility.
