# **WATER AND MAINTENANCE**

- -Ahlers has received a price of \$1831 from Cummins/Rock Island for a new battery charger for the pump house. He will check with Cummins/Bloomington for possible lower price.
- -The water tower will be back in service Wednesday or Thursday of this week. Ahlers will talk to Joe Glynn about the location of the rust spots inside the tower.

#### **SEWER**

- -Gravel and pump have been cleaned at STP
- -Ahlers informed the board that the metal boxes in the septic part of the plant are starting to rot **ENGINEERING**
- -Sandberg has not received any information from Chamlins Engineering concerning street maintenance program.

# **POLICE**

-Sandberg and Vaskie met with Granville Police Chief Kevin Moore and a Granville board member concerning the possibility of entering into an agreement with Granville for police protection. The contract would be a 5 yr. contract with an approximate cost to the Village of \$15,000/yr. This cost includes a police officer, car, and gas. The Officer on duty will make a trip to McNabb 2 times during his 10 hr. shift which averages out to 4 trips to McNabb a day. The officer will be required to make a pass through town and run radar at least 20 minutes for each trip. This contract will also include ordinance enforcement. This will be the same contract that Standard has with Granville.

Putnam County Sheriff's Department and Granville Police Department will respond to all emergency calls in the Village.

Trustees Vaskie, Edens, Haar, and Trone would like Village President Sandberg to pursue this option and meet with Granville Board of Trustees. Trustee Wegrzyn voted no against this agreement.

## **BASEBALL**

-Sandberg stated that the Main diamond in Coleman Park is getting prepped for the Puma Classic that will be held on Sept. 2.

### **NEW BUSINESS**

- -Will ask M. Dennis to spray for weeds on the west side of the library between the curb and street
- -Letter will be sent to Moreno's renter informing him of new dog ordinance requiring him pick up after his dog.
