AN ORDINANCE OF THE CITY OF CISCO, TEXAS, ESTABLISHING THE TAX LEVY FOR THE 2017-2018 BUDGET YEAR OF CISCO, TEXAS; AND ESTABLISHING AN EFFECTIVE DATE. (Second Reading)

C. Consider and Discuss Cooperative Ambulance Service Contract.

Mayor King discussed the meeting held with the cooperative regarding negotiations on the proposed contract that were opposed by the cooperative. Councilmember Campbell went on record saying that he felt the contract should pass and he was in support of the ambulance service at the proposed amount. Mr. Hoffman, Ms. Sloan, and Mr. Matthews all addressed the Council with information regarding the ambulance service including call statistics, budgetary restrictions and how monies were spent or saved. Judge Fields also spoke about the County's contribution to the service and how that covered those areas that were not contributing to the cooperative.

D. Consider and Discuss Ordinance 0-2017-13

AN ORDINANCE OF THE CITY OF CISCO, TEXAS, PROVIDING THAT SHORT, TINDALL, HARRINGTON, COOPER, AND EAST 7TH STREETS AND THE ALLEYS BETWEEN HARRIS STREET AND THE UNION PACIFIC RAILROAD COMPANY'S EASEMENT IN THE HARRIS ADDITION BE CLOSED AND THAT THE DEDICATION OF THE RIGHTS-OF-WAY BE VACATED AND ABANDONED, EXCEPT FOR EXISTING UTILITY AND/OR DRAINAGE EASEMENTS; PROVIDING FOR REVERSION OF THE FEES IN SAID LAND; AND, PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON FINAL PASSAGE. (First Reading)

Mr. Archer explained that City Attorney, Mr. Wright had not yet signed off on this ordinance and had requested further information from the surrounding land owners. Mr. Archer suggested tabling the item pending collection of that information.

E. Consider and Discuss and Potentially Award Contract for Oil Changes on City Vehicles.

Mayor King opened the three bids received. Precision Auto bid \$42.00 per oil change for 6 quarts of oil, filter, and labor. B&Z bid \$30.00 for 6 quarts of oil and a filter, but did not provide any labor costs in their bid, and White's Auto bid \$45.50 for 6 quarts of oil, filter, and labor.

Mr. Archer suggested verifying with B&Z that there would be no labor charge for the oil changes and coming back to this item at the next meeting.
