DISCUSS AND/OR APPROVE REQUEST BY AMERICAN LEGION (Charles Holt) Charles Holt and Lisa Ritter – Mayor, Ladies and Gentlemen of the Board. Although it's May, the fourth season of Fair Grove's Main Street Christmas tradition will be here before we can say Ho Ho.

The Fair Grove Area Chamber of Commerce has formed a Main Street Christmas palling committee composed of several businesses, individuals and organizations. We have been meeting since early February to plan 2024 Main Street Christmas activities. We will give you a broad overview of the festive plans followed by a request from our committee.

We will continue featuring Thursday nights as we have previously done with extended shopping hours along with free tours of the historic Wommack Mill. The dates are Thursday, December 5<sup>th</sup>, 12<sup>th</sup>, and 19<sup>th</sup> from 5-8pm. In addition to the lights and decorated windows on Main Street, we will encourage businesses along Old Mill Road to also participate in lighting up our town. Something new will be approximately ten trees with commercial lighting located on the Historical Society grounds near the gazebo, Livery Lane and windmill.

Saturday, December 7<sup>th</sup> follows the tradition of a day of shopping, activities for children held by the Park Board then the evening Christmas Parade sponsored by the Fire Protection District. Lineup is at the high school parking lot at 4:30pm. The parage begins at 5pm followed by the tree lighting, caroling and other activities at the Wommack Mill.

The new exciting addition to this year is special activities on Saturday, December 14<sup>th</sup>. This day will feature a Christmas Market and live nativity in the evening. The Christmas Market will be filled by ho9liday vendors set up along Main Street and primarily in the square area. Santa will be present through the connections of Spangle the Clow. The live nativity will take place in the evening at the Historical Society's gazebo area. Local churches will also add to the holiday spirit there with caroling and musical performances.

Now our request: We ask that Main Street be closed on Saturday, December 14<sup>th</sup> from 7am to 8pm. This closure allows vendors to begin setting up at 7am and be ready to open at 10am. The will operate until 5pm when they close at dusk, although there may be some continuing further into the evening. Visitors will go on foot to see the live nativity which will close at 8pm. Main Street then reopens to traffic at 8pm.

Fair Grove is all about small town charm and the is especially true at Christmas time. Main Street Christmas will provide local businesses the opportunity to garner sales on these dates, generate sales tax revenue for the City and provide exposure to organizations such as The Historical Society, Fair Grove Parks and local churches. Above all, we see our Main Street Christmas activities as a time to put a beautiful spotlight on Fair Grove where citizens and visitors alike come to make holiday memories.

## DISCUSS WASTEWATER TREATMENT BID

Roe said we have two oxidation ditches and the belt system is notorious for breaking down. Company from AZ came out and looked at it and gave us a bid for bearing for clarifier. \$90,000 for that. After talking to engineer, everything is expensive. Sewer committee decided it should go out to bid, worked on bid specifications. Left it generic. Andy added legal terms, almost ready. Needs permission to move forward and to give the Board awareness. Expects to take out of capital funds and the sewer. Danderson says it will have to be a sealed bid and be posted and published but just wanted to make sure that everyone is aware before it is brought to the board. Consensus from the board to get it in bid form and put in packets to see the bid form and get a

motion then to move forward. 8 week lead time to move forward. No one in Springfield does it. Let attorney look at it if everyone agrees. Consensus to move forward.

## Mayor Report

Explains that Superintendent requests school accomplishment signs be posted on city limit signs on Highway 65. Spoke to Sara and she said she would contact MoDot. The school will take on the cost. Can we move forward with that? Icenhower says the school asked MoDot about it. They aren't going to do it. Lincoln Hough came in and spoke to Icenhower. Told him that he thinks that he has it done. Lincoln called a while ago and it's just a formality, because it's a city of Fair Grove sign, the city has to give consent. Doesn't see why we can't get it done. Sara directed by Board to contact MoDot.

I am pleased to provide you with an update on recent developments and interactions that have taken place in the interests of our city.

Firstly, I successfully established contact with Total High Speed and I am delighted to report that we have recovered \$2450.00 from Total High Speed that was paid last meeting to LaFollette Excavating. Also, I recently engaged with Chris Gaut from the State of Missouri Department of Public Safety, State Emergency Management Agency. Our discussions centered around emergency preparedness and response strategies to ensure the safety and well-being of our residents. I have pass this information along to Ben Lord as he is the Chairman over Emergency Management.

Furthermore, I had the honor of being the guest speaker at a recent Chamber of Commerce meeting, where Sara and Chandra also attended. During the event, I had the pleasure of meeting Jake Phillips from SMCOG. Jake expressed great enthusiasm with progress they are making in updating Fair Grove's comprehensive plan and has offered his assistance in securing funding and grants to propel our city forward when the time comes.

Moreover, I had a productive conversation with Tucker Jones, the District Director for Senator Eric Schmitt. Tucker has valuable contacts that could aid us in obtaining grants to support our community that he said he is willing to help get us in touch with when it comes to our water treatment facility/ sewer system and streets.

In light of these engagements and networking opportunities, I kindly request the council's approval to order business cards for me. Having business cards would facilitate networking and communication with individuals and organizations that can contribute to the growth and betterment of our city. Roe and Icenhower are okay with it.

Icenhower – About the S.R.O.?

Mayor – I have talked to him about the S.R.O.

Icenhower – At that point and time, you weren't even Mayor, right?

Mayor – I didn't ask him any questions, Mr. Icenhower that would have referred to me being the Mayor. I asked general knowledge questions.

Icenhower – Well that is not what I understood. Also, we have hired a police chief to hire police officers and we went down this road. What caused all of the big uproar before, to be honest about it, the council didn't do their jobs and we got some officers in here that created problems. And I respect Chief Roy that he's got a good enough judgment to hire officers and we need to worry about quality not quantity. We don't need to worry about numbers, we would love to have them but if they don't pass the background check or whatever. If it doesn't work out, it's going to be his face on the wall. Not mine, not yours, none of us. The third thing is, you stood in front of this council and you went on TV bad mouthing this council and you're going to have a hard time getting respect out of this council for what you did. I know that you had a letter of apology the other night but an apology doesn't mean anything to me. Actions speak louder than words and I know what your actions were prior and I hope you're smart enough to stay out of trouble but if your not careful, you're going to get in trouble.

Mayor – I guess my question to you Mr. Icenhower, thank you for that. What do you mean by that as I uh, that I'm going to get in trouble because I don't feel like I've overstepped any boundaries.
