Cost Share Funding Recall -

This makes it look like there isn't a demand for the funds, which is untrue. Board desires to send a letter to state legislators stressing ongoing lack of technical help as reason funds are being returned.

REAP – Voluntary December 30th date.

FARMS Audit Request – Siefken forwarded 7 FARMS cost share folders to IDALS for accounting review.

Cover Crop Deadline Extension – NRCS extended the deadline to December 21st with stipulations and required spring field checks. WQI will just require seed was planted and pay this fall.
