Keynote Presentation

Behavior Change is a Process; Not an Event

One of the most common and persistent concerns expressed by teachers is how to effectively deal with challenging behavior. Non-compliance, talk-outs, failure to engage in assigned tasks, and disrespect often top the lists of behaviors that result in the disruption of effective instruction. With larger class sizes, an increase in the number of students displaying emotional, behavioral, and mental health disorders, and greater demands for academic excellence, the need to effectively address undesired behavior is an even greater challenge in today's classroom. This keynote address will explore challenging behavior and identify a number of effective low demand strategies that take advantage of existing teacher behavior to

more effectively prevent and deal with challenging student behavior. Armed with this information, school social workers can assist and support classroom teachers in meeting the needs of students who are failing or who are at-risk for school failure.

Biographical Information

Dr. Richard Van Acker is an Emeritus Professor of Special Education at the University of Illinois at Chicago. Dr. Van Acker began his career in education as a high school math and

science teacher. His ability to work effectively with troubled youth resulted in his becoming a teacher of students with emotional and behavioral disorders. He also worked as a child care worker in a residential center for children and youth with emotional disorders. Since earning his doctorate, Rick has been engaged in teacher education at UIC. His research explores the development of antisocial behavior in children – attempting to identify effective prevention and intervention strategies. Rick has served as president of the International Council for Children with Behavioral Disorders (a Division of the Council for Exceptional Children). He continues to serve on the Professional Development Committee of that organization as well as that of the Midwest Symposium for Leadership in Behavioral Disorders. Rick's research has been published in over 100 professional journal articles, book chapters, monographs and books. His latest book is titled 'Cognitive Behavioral Interventions for Emotional Disorder: School-Based Practice'.

Session I: 1:30-2:45

A. Open Discussion/Round Table

Speaker: Richard Van Acker, PhD Emeritus Professor of Special Education, University of Illinois at Chicago This workshop is your chance to come and discuss behaviorally challenging students, families, and/or instructional situations. Perhaps current intervention efforts are not proving effective or are too difficult to implement within the school setting. Bring your data, current functional behavior assessments, behavior intervention plans, or just your ideas and concerns. Together as a group, with Dr. Van Acker's direction, participants will attempt to provide insight and guidance to a more effective approach. This workshop will be limited to 30 people due to the discussion format and is geared toward practitioners in grades K-12.

B. Applied Ethics

PBIS is a philosophy that emphasizes systems of support that include proactive strategies for defining, teaching, and supporting appropriate student behaviors to create positive school environments. Participants can expect to learn basic information about PBIS, how to assess what your school is currently doing with PBIS, and how to support PBIS initiatives as a school social worker. Examples of proactive strategies and behavioral interventions across behavioral tiers will be presented and discussed. This workshop is geared toward practitioners in grades K-12.


