## ORDINANCE NUMBER 17.

AN ORDINANCE LICENSING THE SALE OF NON-INTOXICATING BEVERAGES AND REGULAT-ING THE BUSINESS OF VEND-ING THE SAME AT RETAIL.

The Village Council of the Village New Munich, Stearns County, Minnesota, do ordain as follows:

Section 1. No person shall engage in the business of selling or vending non-intoxicating beverages, at retail, within the said Village of New Munich, without first having obtained a license therefor.

Section 2. Every person requiring a license under the provision of this ordinance shall pay the sum of Twenty-five dollars therefor. sum of

Section 3. Every person requiring a license under the provision of this ordinance shall pay to the Village Freasurer of said Village the sum of Twenty-five dollars, taking his receipt therefor, which said receipt shall be presented to the Recorder of said Village, together with an application, describing the place in which such applicant proposes to engage in such business, and the recorder shall present such application to the Village Council, at the next regular or special meeting of said council thereafter; and in case such application is granted, the Village Recorder shall issue to such applicant t license, under his hand and the seal of said Village, describing the place in which said business is to be conducted, granting to such applicant the privilege of carrying on such business, at such place, for a period of one year from the date thereof, and thall bear date of the time of granting of such application. No license shall be for a shorter period than one vear, and after the granting of such license, no part of such license money hall be refunded. In case said Village Council should refuse to grant any such license, it shall order the return of such license money to such applicant, and the Village Recorder shall, immediately issue an order up-on the Treasurer of said Village, pay-able in the sum of Twenty-five dollars to such applicant.

Section 4. All places, except drug stores, whene such non-intoxicating beverages are sold shall be closed at 11 o'clock P. M. of each day and be kept closed until 5 o'clock A. M., on the following days and series of the following days and series of the s the following day, and every Sunday from 10 o'clock A. M. to 11 o'clock

Section 5. Any person convicted of a violation of any of the provisions of this ordinance, shall be punished by a fine of not to exceed one hundred dollars, and not less than one dollar, or be confined in any place of confinement maintained by said village or in case there be no such place, then to be confined in the county jail in the county in which said Village is located not to exceed the term of ninety days, provided that such imprisonment mer he cumulative or for an indefinite term, not to exceed ninety days, subject to suspension and termination by reason of or during the good behavior of the person imprisoned.

Section 6. This ordinance shall take effect and be in force from and after the first day of June 1923.

## ORDINANCE NUMBER 18

n ordinance amending Sections 2 and 3 of Ordinance Number 17, an ordinance licensing the sale of non-intoxicating beverages and regulating the business of vending the same at retail.

The Village Council of the Village of New Munich, Stearns County, Minnesota, ordains that Sections 2 and 3 of Ordinance No. 17 be amended to read as follows:

Section 2. Every person requiring a license under the provision of this ordinance shall pay the sum of \$25.00 therefor for a period of one year, or \$7.50 therefore for a period of three months.

Section 3 Every person requiring a license under the provision of this ordinance shall pay to the Village Treasurer of said Village the sum of \$25.00 for a period of one year, or \$7.50 for a period of three months, taking his receipt therefor, which said receipt shall be presented to the Recorder of said Village, together with an application, describing the place in which such applicant proposes to engage in such business, and the recorder shall present such application to the Village Council, at the next regular or special meeting of said council therefor; and in case such application is granted, the Village Recorder shall issue to such applicant a license, under his hand and the seal of said village, describing the place in which haid business is to be conducted, granting to such applicant the privilege of carrying on such business, at such place, for the period stated in said upplication, and shall bear date of the time of granting of such application. No license shall be for a shorter period than three months, and after the granting of such license, no part of such license money, whether for three months or for one year, shall be refunded. In case said illage council should refuse to grant any such license, it shall order the return of such license money to such applicant, and the Village Recorder shall immediately issue an order upon the Treasurer of said village, payable in the sum of \$25.00, in case the application shall be for a period of one year, and \$7.50 in case the application shall be for a period of three months, to such applicant.
