- Risk-management procedures for your practice and guidelines for compliance with the law
- Changes in Colorado Mental Health Law and Rules that went into effect in 2011 and 2014
  - A review of Colorado Mental Law, recent changes, and other relevant State statutes
    - Protocols to handle potentially suicidal, violent, and homicidal clients.
    - Ways to safeguard client confidentiality and protect your practice.
    - How to respond to a complaint to your DORA regulatory board
- The wisdom of seeking legal advice and representation during a crisis, grievance, or lawsuit
