9. Action Items

- a. Approve Temporary City Policy: Response to COVID-19
 - 1)City Manager Susie Marston stated that this temporary city policy was drafted from a template created by the City of McMinnville. This policy states that the City of Gervais will be following the guidance outlined by the Governor's Office, OHA, CDC and Marion County Health and Human Services. This policy also puts some added protections in place for employees who become affected by COVID-19. An additional leave of 80 hours is allowed so that employees who are ill or caring for an ill family member do not to have to use their normal accrued leave. This additional leave will be tracked separately. There was brief discussion about employees working remotely.

Councilor Wagner made a motion to approve the temporary city policy: response to COVID-19. Seconded by Councilor Leiva. Motion is unanimously carried and so moved.

- b. Resolution No. 20-002
 - 1)Mayor Platt stated that this resolution creates a temporary city policy that describes the procedures that Gervais can take in response to a declared emergency.

Councilor Wagner made a motion to adopt Resolution No. 20-002 declaring a temporary state of emergency within the boundaries of the City of Gervais and delegating authority to the city manager. Seconded by Councilor Gregory. Motion is unanimously carried and so moved.

10. Staff Reports:

a. City Manager

In response to the declaration from Governor Brown, the next two court dates will be canceled. City Hall will also be closed to the general public starting March 18th. Employees will still come to work with business be conducted over phone and via the drop box. Information about the temporary closure will be posted on the City Hall doors and website.

There is a pre-construction meeting scheduled for next week for the Ivy Woods project. The meeting may be done by tele-conference. The 4th Street project has begun this week.

b. Police Department

Chief Chase encouraged everyone to gather information from the official channels to get the most accurate information regarding COVID-19.

c. Public Works

There will be minor changes to the designs for the 4th Street Project. The street is shut down to through traffic but is open to those living on 4th Street.

11. Business from the Mayor or Council

District will be distributing lunches to student homes in Gervais during the time classes are canceled. The Mayor also talked about caring for the elderly citizens in Gervais. There was a brief discussion about CERT welfare checks in Gervais. Chief Joe Budge spoke about the welfare checks. Councilor Harvey asked about how City Hall will assist the public during the closure. Susie said that payments can be made through the drop box and mail. Councilor Harvey also asked about cleaning supplies at City Hall. There was a brief discussion about supplies.

INTERGOVERNMENTAL AGREEMENT PW-***-** BETWEEN MARION COUNTY AND CITY OF GERVAIS FOR COMMUNITY EMERGENCY RESPONSE TEAM TRAILER STORAGE

THIS AGREEMENT is by and between Marion County, by and through its Public Works Department, hereinafter referred to as "County" and the City of Gervais, hereinafter referred to as "City".

1. City Responsibilities:

- 1.1. City shall grant County authority to enter onto their property located at 35 Juniper Avenue, Gervais, OR 97026, for the purpose of storage of a trailer to remain there for use by County personnel and authorized volunteers including, but not limited to, members of a Community Emergency Response Team (CERT).
- 1.2. City shall provide access, twenty-four (24) hours a day, seven (7) days a week, to the storage location to County personnel and authorized volunteers including, but not limited to, members of a CERT.
- 1.3. City shall report any damage believed to be a result of County use of the City property immediately upon discovery. Direct such reports to the Emergency Manager at 503-365-3133. City shall not repair, nor have repaired, any damage prior to inspection, verification, and authorization by County to repair damage determined to be the result of activities of County.
- 1.4. City shall not hinder or deny access to the site unless prior arrangements have been made with County.

2. County Responsibilities:

- 2.1. County shall secure the trailer and be responsible for the theft or misuse of any items stored in the trailer.
- 2.2. County shall notify City of any damage to City property as soon as is practicable.
- 2.3. County shall be responsible for the repair of any damage to City property resulting from County use thereof. Any repairs made shall be made so as to return the property to, as nearly as possible, the same condition as existed prior to the use of the property by County. Every effort shall be made to repair reported damage within five working days from the date of report of the damage, and confirmation that the damage is a result of County activities.
- 2.4. County shall remove all materials and/or equipment upon sixty (60) days' notice from City. After all materials have been removed, County shall restore the property to, as nearly as possible, the same condition as existed prior to the use of the property by County.

3. General Provisions:

3.1. Indemnification:

Each agency shall agree to defend, indemnify, and hold harmless the other agency, its officers, agents, and employees from damages arising out of the tortious acts the other agency, its officers, agents, and employees acting within the scope of their employment and duties in performance of

this agreement subject to the limitations and conditions of the Oregon Tort Claims Act, ORS 30.260 through 30.300, and the Oregon Constitution, Article XI, Section 7.

Nothing in this agreement shall be deemed to limit the right of either party to make a claim against the other for damages and injuries incurred by one party as a result of the actions of the other party's officers, agents and employees.

3.2. Term of Agreement:

This agreement shall be effective as of the last authorizing signature obtained below, and shall continue in effect through December 31, 2024. This agreement may be extended for an additional period of five years by agreement of the parties. Any modifications of the terms of such amendment shall be in writing.

3.3. Termination:

All or part of this agreement may be terminated by mutual consent of both parties; or by either party at any time for cause, upon sixty (60) days' notice in writing to the other party.
