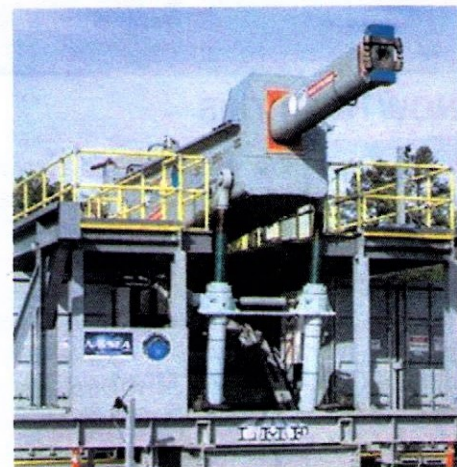

Richmond Council's Annual Sea Services Luncheon will feature an address by Commander Matthew Shellock, USN of the **USS CARTER HALL (LSD-50)**. CDR Shellock earned a Bachelor of Science degree in Ocean Engineering from the U.S. Naval Academy and was commissioned there in 2001. He has been deployed in the Arabian Gulf, the Horn of Africa, the Pacific and served ashore at the Pentagon and Norfolk. In 2018 he assumed duties as Executive Officer aboard **CARTER HALL**. 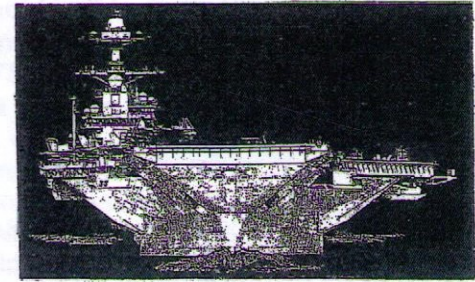

## IS THE ERA OF THE FLAT-TOP FADING?



Pearl Harbor transformed the U.S. Navy from a battleship dominated force to one led by aircraft carriers.

Fast forward to 2019 and now the use and viability of the carrier is being questioned.

Navy Times has interviewed several officials, including a naval think-tank leader and a former Deputy Secretary of Defense, both of whom express concern about the future of the flattop as it is currently employed.

Increasingly sophisticated anti-ship missiles have been developed by China and Russia. They pose an unacceptable threat level to the carrier which requires it to be operated hundreds of miles from intended targets and beyond the strike range of Navy jet fighters.

Another problem is the enormous cost of the Ford-class carrier (\$65 billion) which limits the Navy from being able to develop smaller, relatively inexpensive, unmanned warships which could constitute our first line of attack. The risk of loss of such drone vessels would be significantly lower in terms of cost and without loss of human life.

Without question there is political pressure to continue the maintenance and construction of the carrier. Even those who question their current utilization agree that they have a future. Politics was clearly involved when the Navy announced that it was going to decommission **USS TRUMAN** rather than incur the expense of mid-life overhaul. The political outcry caused a complete reversal of the decision.

The development of carrier-based drone refueling tankers (MQ-25 project with Boeing) will give the fighter aircraft a much greater range and thus allow the carrier to remain out of range of hostile missiles. Carrier proponents see this as an assurance of their continued utility. Currently, it is "wait and see".

Greetings from **USS GRAVELY**! August was a very eventful month for **GRAVELY** as we completed our final mission of deployment and returned home to reunite with our families. The month began with gloomy news. Leaving Rota and driving a course to arrive in Norfolk on August 10<sup>th</sup>, we learned that our deployment would be extended by three weeks. The Second Fleet Commander required a ship to fulfill national tasking and operate north of Arctic Circle in Baffin Bay, west of Greenland. Several ships were nominated for the tasking, but **GRAVELY's** reputation for mission accomplishment made us the preferred ship! The crew took a day to absorb the news, but quickly recovered, ready to tackle any and all challenges involved with

this mission. From Rota we traveled to Ponta Delgada, Azores to top-off on fuel and then traveled to Halifax, Nova Scotia to prepare for our Arctic Operations. While in Halifax, Commander Michael O'Reilly relieved Commander Justin Hodges as Commanding Officer of **USS GRAVELY**. The change of command ceremony was simple based on our operational tasking, but still steeped in naval tradition. The crew bid farewell and following seas to Commander Hodges, the Captain who led us through a challenging year and a half, 395 days underway and some forty-five thousand nautical miles traveled. Assuming the reins, Commander O'Reilly led **GRAVELY** into uncharted territory, areas where US navy ships have never operated. We maintained constant communications with the Fleet Weather Center during our transit north, driving to avoid icebergs that became more and more present the farther north we travelled. **GRAVELY** operated north of the Arctic Circle before turning the ship south and charting a course for home. We stopped in Halifax to refuel and returned home days later, meeting our children and families on the pier, loved ones whom we last held 245 days ago. As August ends and as we catch up on lost time with friends and family, we reflect proudly on the last eight months. The crew served well, professionally representing the US Navy and the United States of America during our deployment to Sixth and Second Fleets as part of the Standing NATO Maritime Group. ✍

**NORTHLAND** has successfully been underway for almost three weeks and the crew has filled the time with training, qualifications, and even some excitement! The first two weeks of the patrol consisted heavily of flight operations, with our embarked helicopter, to practice techniques and procedures necessary for interdicting high-speed narcotics smuggling vessels at sea. We have also taken advantage of having the helicopter on board to assist our newest members in earning their flight deck qualifications.

While transiting to the Eastern Pacific, we received direction to intercept a potential target of interest. After a full day of diligently searching, **NORTHLAND** inter-

A Challenge Coin has traditionally been given to someone to confirm membership in an organization or group, to award special service, to enhance morale, to exchange during visits, or even for identification behind enemy lines. All of these uses are more important than legends about slapping the coin on the bar to decide who buys the next drink.

Putting your Challenge Coin in someone's hand means that you're giving it to them. However, there is no need for this secret handshake maneuver. Instead, showcase the coin by holding it out in front of you in the palm of your hand. The idea is to prominently and proudly display the coin as you speak about it - The Richmond Council Navy League Challenge Coin. ✍

cepted the vessel and began what turned into a grueling, four-day law enforcement boarding. The boarding teams worked thoroughly and tirelessly, searching the massive vessel in deteriorating weather conditions until, on the third day, they discovered bales of contraband. The next challenge we faced was how to safely transfer the contraband from the vessel to **NORTHLAND**. Many ideas later, we settled on utilizing our small boat to transport as many bales as we could to **NORTHLAND**, tossing a line with a clip to the small boat to attach to the bale, and using sheer manpower to pull each, individual bale onto the ship. After weighing all of the contraband, we calculated its total weight to be approximately 4,200 kilograms, making this interdiction the largest Caribbean Sea/Atlantic Ocean, non-semi-submersible drug interdiction in more than seven years. Every single member of the crew, from the galley staff to the boarding team members to the Bridge, Engineering, and Combat watchstanders, played an integral role in making this drug interdiction possible. This was the first major contraband interdiction for the majority of the crew, and it will definitely be a moment that they will remember long after their Coast Guard careers are completed.

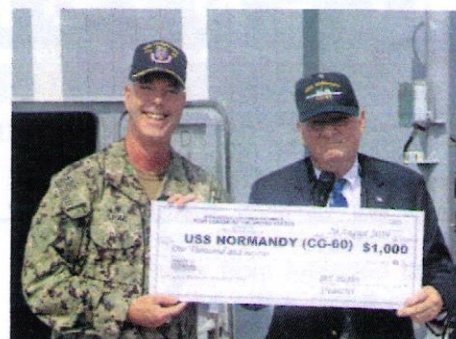
This has been an exceptionally strong start to the patrol and we hope to have more cases that are equally as successful in the coming months.

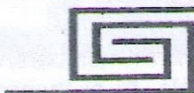
### NATIONAL MARINE CORPS MUSEUM TRIP

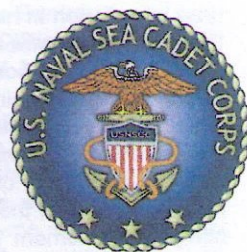

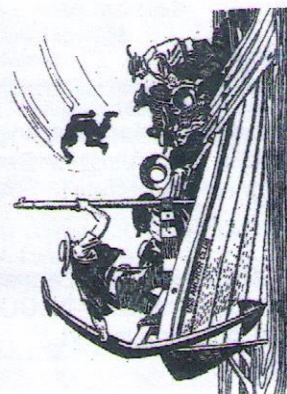
